

**EXPLANATION OF COMPLIANCE
WITH
MULTIPLE OWNERSHIP RULES**

Mr. Fred Eychaner, through common ownership, presently holds an attributable interest in six stations (five AM stations, and one FM station) in the Chicago radio market: WAIT(AM), Crystal Lake, IL; WCFJ(AM), Chicago Heights, IL; WCSN(AM) and WSBC(AM), Chicago, IL; WNDZ(AM), Portage, IN; and WRZA(FM), Park Forest, IL.

Mr. Eychaner is simultaneously acquiring WKIE(FM), Arlington Heights, IL; WKIF(FM), Kankakee, IL; and WDEK(FM), DeKalb, IL.

The attached statement of Mr. Louis Robert du Treil, Jr., P.E., demonstrates that assignment of WKIE(FM), WKIF(FM) and WDEK(FM) to entities commonly owned by Mr. Eychaner, as described above, are permitted under FCC rules.

Engineering Statement

This Engineering Exhibit has been prepared on behalf of Fred Eychaner (herein “Eychaner”), who is the sole shareholder of individual corporate entities, which are the present licensees of five AM stations and one FM station in the Chicago, Illinois area. These stations are listed on Figure 1. Eychaner intends to acquire three FM stations also listed on Figure 1. This ownership study has been prepared because these stations have overlapping principal community contours.

Figure 2 is a map showing the principal community contours of the five Eychaner stations and the 3 FM stations to be acquired. As will be noted, the principal community contour of FM station WDEK DeKalb, IL does not overlap the principal community contours of any of the other stations, so it is excluded from the ownership study.

The overlap of the principal community contours of stations WAIT, WKIE, WSBC and WCSN comprise Market No. 1. The pertinent contours of these stations are shown on Figure 3 along with the principal community contours of any other intersecting AM or FM stations.

The overlap of the principal community contours of stations WKIF and WRZA form Market No. 2. The pertinent contours for stations WKIF and WRZA are shown on Figure 4, along with other AM or FM stations, which provide principal community coverage to any part of the market.

The number of stations in a market is determined by counting the commercial stations having principal community contours, which overlap or intersect the principal community contours defining the radio market. With respect to Market No. 1, there are 76 stations meeting the coverage requirement. For Market No. 2, there are 48 stations meeting the coverage requirement. The proposal of Eychaner to acquire the three listed FM stations greatly exceeds the ownership requirements of 47 CFR 73.3555.

The stations providing a principal community contour to either market are listed in Figure 5. Due to the extensive number of stations involved, identification of each contour was not attempted.

Geographic coordinates for the transmitter sites of stations shown herein were obtained from the FCC computer database. The 5 mV/m contours for AM stations were determined from data contained in the Commission's database and the appropriate Ground Wave Field Strength versus Distance Graphs of 47 CFR 73.184. Estimated ground conductivity is from the Commission's conductivity map, Figure M-3. Available measured conductivities are not expected to materially change the location of any of the AM station contours.

Distances to FM contours were determined based on the method of 47 CFR 73.313, utilizing 36 radials. FM station effective radiated power and antenna height above average terrain were taken from the FCC computer database.

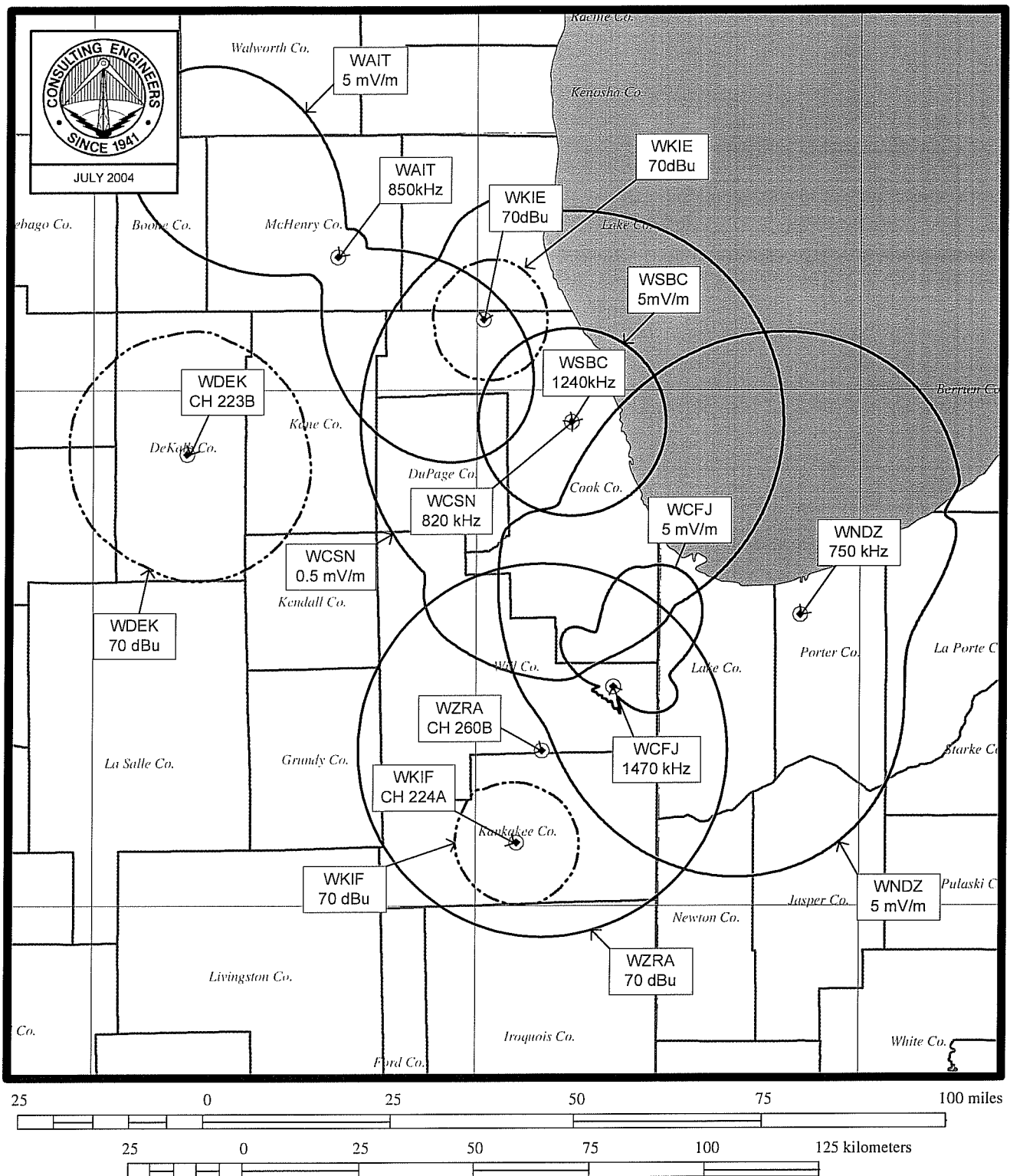

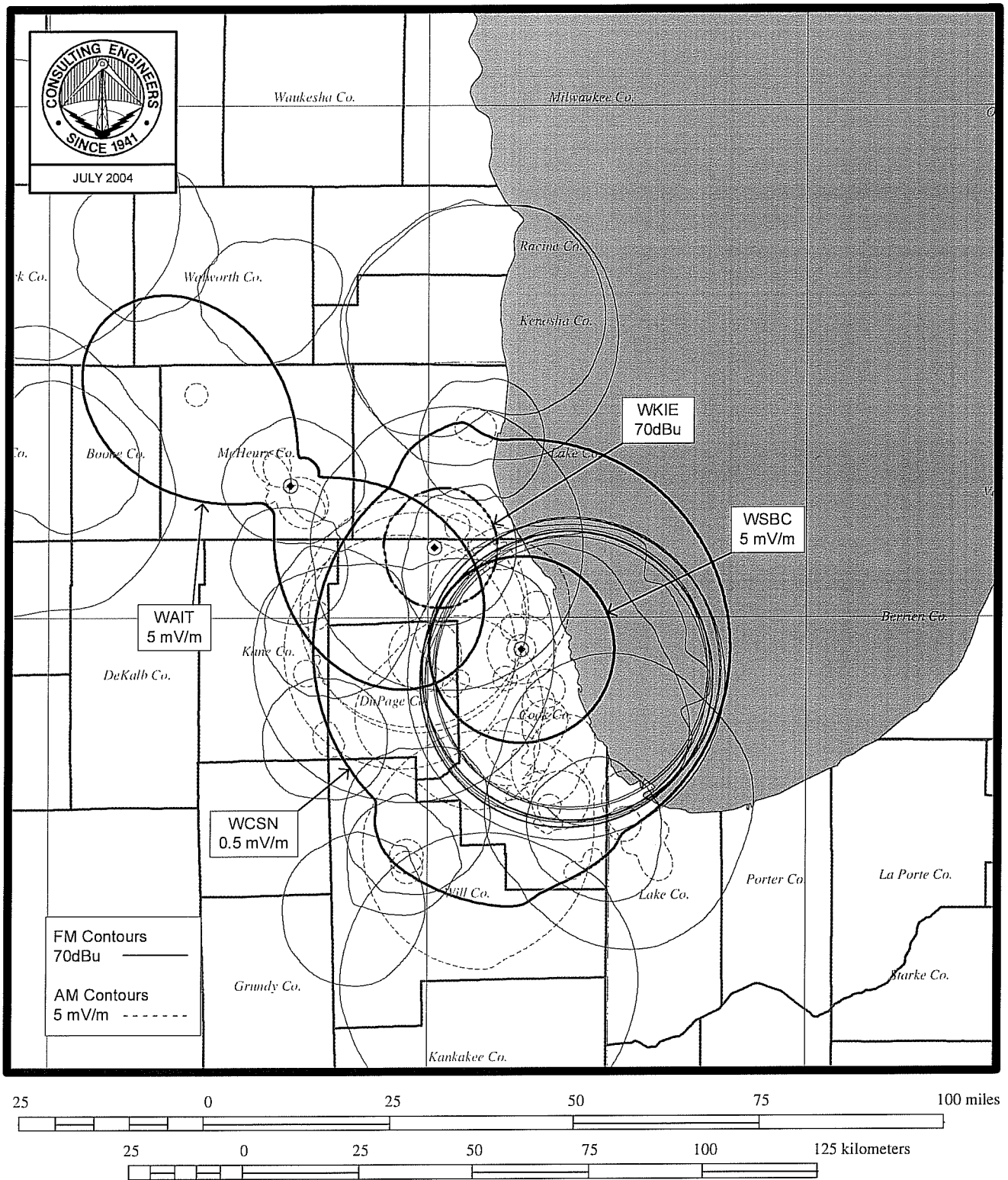

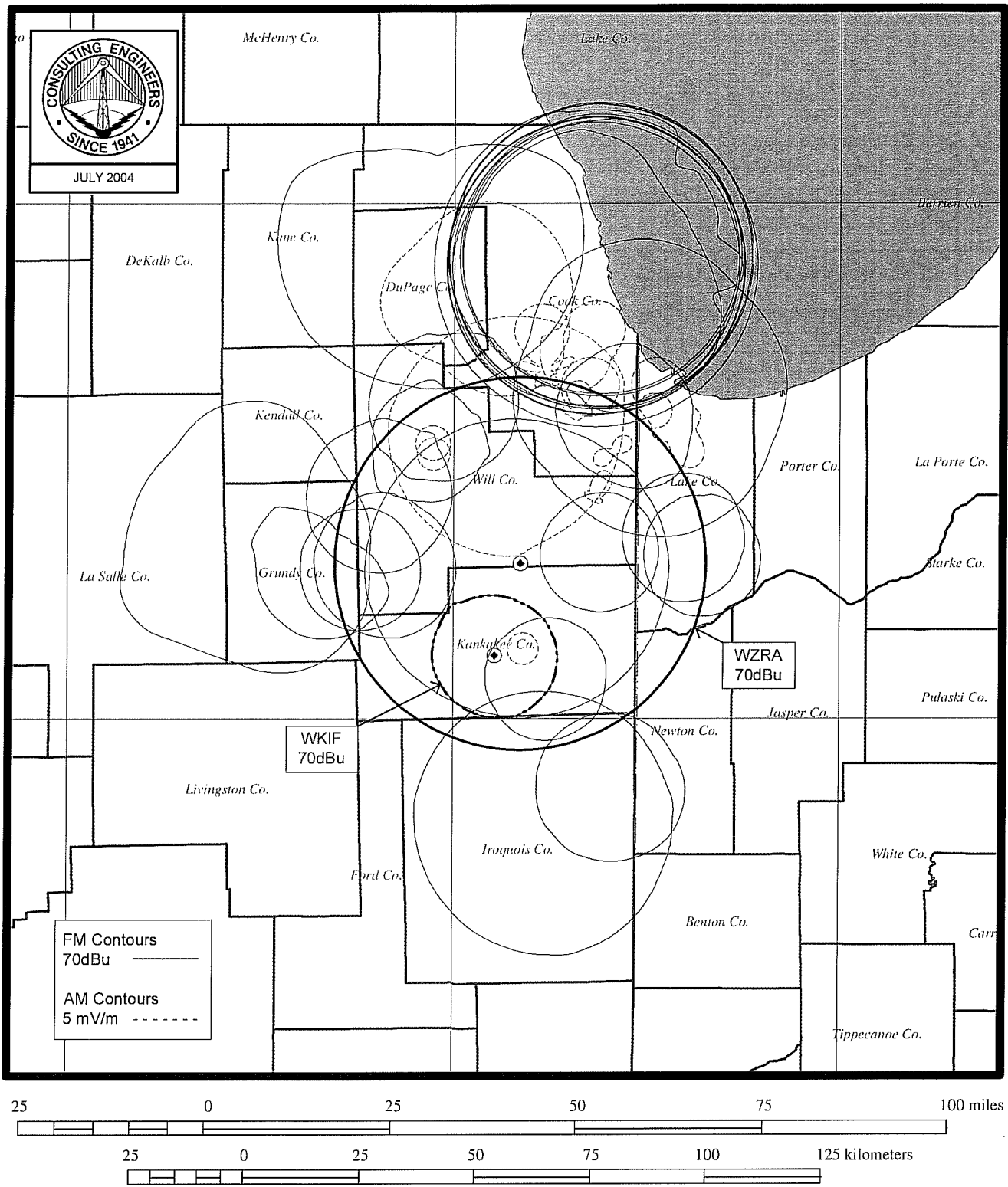


**OWNERSHIP STUDY
