Interference Considerations

The transmitter site for WXRV(FM) proposed in this application is the same as that for the existing operation of the station. The location of this site conforms with the distance separation requirements of Section 73.207 of the Commission's Rules for a Class B station with respect to existing stations, construction permits, pending applications, channel allotments and rulemaking petitions in the United States on the pertinent channels, with the exceptions that are discussed in this Exhibit.

Table A of this Exhibit shows the distance from the proposed WXRV(FM) transmitter site to each existing station, construction permit, pending application, allotment and rulemaking petition in the United States within 300 kilometers for Channel 223 and the first adjacent channels; within 150 kilometers for the second and third adjacent channels; and within 50 kilometers for the frequencies removed by 53 and 54 channels from Channel 223. As shown in Table A, the proposed transmitter site conforms with the distance separation requirements of Section 73.207 of the Commission's Rules, or with the minimum permitted short spacings of Section 73.215(e) of the Rules, as is applicable, with the exception of four grandfathered short spacings. The grandfathered short spacings are to WWYZ(FM), Waterbury, Connecticut; WPRO-FM, Providence, Rhode Island; WBOS(FM), Brookline, Massachusetts; and WUMB-FM, Boston, Massachusetts; and are discussed in Exhibits 26 and 28 of this application. WXRV(FM) receives contour protection from short-spaced station WFEX(FM), Peterborough, New Hampshire, under Section 73.215 of the Rules; the existing WXRV(FM) transmitting facilities were not authorized under Section 73.215, and consideration under Section 73.215 is not requested in this application.

Additionally, the studies for Table A of this Exhibit showed that the proposed WXRV(FM) transmitter site conforms with the distance separation requirements for a Class B station as set forth in Paragraph 2.4 of the "Working Arrangement for the Allotment and Assignment of FM Broadcasting Channels Under the Agreement Between the Government of Canada and the Government of the United States of America Relating to the FM Broadcasting Service," dated February 1991 (as amended in 1997), with respect to stations and allotments on the pertinent channels in Canada.
