Pursuant to Attribution of Ownership Interests, 97 FCC 2d 997 (1984), information has been reported only for those individuals who are officers and directors and the single majority voting shareholder of Saga Communications, Inc. Each share of Class B Common Stock (which is held only by the single majority voting shareholder) entitles the holder thereof to one vote in the election of directors and ten votes on the other matters to be voted upon at the annual meeting of the corporation. See *Review of the Commission's Regulations Governing Attribution of Broadcast and Cable/MDS Interests* (MM Docket Nos. 94-150, 92-51 and 87-154), 16 FCC Rcd 22310 (2001).
