

### **Non-Commercial Qualifications**

The instant application is filed in connection with an application for assignment of the license for KDSP (FM), Greenwood Village, CO., from Front Range Sports Network, LLC ("Front Range") to Public Broadcasting of Colorado, Inc. aka Colorado Public Radio or "CPR." The purpose is to secure Commission approval for a change in KDSP's status from commercial to non-commercial effective upon the closing of the transaction, and thereby satisfy one of the conditions precedent to consummation. Attached to this Exhibit is authorization from Front Range to file this application.

Colorado Public Radio holds Commission licenses for 12 full-service radio broadcast stations, and seven FM translators, all serving the State of Colorado and all non-commercial. CPR's licenses were renewed principally in March 2013. See, e.g., BRED- 20121126AEH. A list of CPR's stations is attached as Exhibit 4.


CPR's mission is to provide educational, news, and cultural programming for citizens of Colorado. Its programming includes, for example, "Morning Edition" and "All Things Considered" from National Public Radio; classical and new music; and local news and information. Its non-commercial qualifications are a matter of record with the Commission. See letter from Peter Doyle, Acting Chief, Audio Services Division to William K. Keane, counsel for CPR, dated August 17, 2001 (approving change of status for KCFC (AM) to non-commercial educational incident to that station's acquisition by CPR). Section II of FCC Form 340 is attached.

For the foregoing reasons, the change in KDSP's status to non-commercial educational is requested effective upon the closing.

**CONSENT**

Front Range Sports Network, LLC, licensee of KDSP(FM), Greenwood Village, Colorado, hereby gives its consent to the filing by Public Broadcasting of Colorado, Inc. ("PBC") of an application on FCC Form 302 during the pendency of the assignment of KDSP(FM) to PBC.
