There is no written agreement regarding the instant *pro forma* voluntary transfer of control application for Northwestern University, the applicant herein and the licensee of WNUR-FM, Evanston, Illinois, a noncommercial educational station, Facility ID 48779. Rather, this application seeks the Commission's approval, *nunc pro tunc*, following periodic changes in membership of Northwestern University's Board of Trustees and officers over the years through the election of new trustees and the appointment of new officers. At no time was there ever a 50 percent or greater transfer of control.

WNUR-FM was licensed in 1950. Pursuant to the advice of previous communications counsel, and after consultation by counsel with Commission staff, Northwestern University has never filed a transfer of control application.

However, Northwestern University has employed new communications counsel who recently consulted with the Audio Division staff regarding the university's changes in membership of its Board of Trustees and university officers since 1950. The Audio Division informally advised Northwestern University to file a Form 316 application and include year-to-year data demonstrating the changes in the membership of the university's Board of Trustees and officers, beginning with 2001. Such data is provided in the exhibits attached to the instant application.

Attached hereto are tables listing the members of the Board of Trustees and officers for Northwestern University for 2001-2002, 2002-2003, 2003-2004, 2004-2005, 2005-2006, 2006-2007, 2007-2008, 2008-2009, 2009-2010, 2010-2011, 2011-2012, and 2012-2013.

Beginning with the 2001-2002 table and continuing through the 2011-2012 table, the name of any trustee or officer who did not serve the following term is listed below the table.

Beginning with the 2002-2003 table and continuing through the 2012-2013 table, the name of any newly elected trustee or newly appointed university officer for that term appears in **bold letters** in order to differentiate that trustee or officer from persons who already had been serving on the Board of Trustees or who already had been serving as university officers.

The final table attached hereto lists all appointed trustees and newly elected officers since 2002-2003, noting which year they were newly elected or appointed.
