The management of Investors is almost entirely within the power of its Board Members¹ and voting power in Investors is best described in terms of an individual or entity's power to elect Board Members. For purposes of discussing board representation, the members of Investors can be divided into the following seven categories: TWP Members, Management Members, Weston Presidio Members, ALTA Members, PNE Members, and Goldman Sachs Members (all of whom hold Class A membership interests in Investors), and the Class B and the Class C Members.

The Board of Investors can consist of as many as eight Board Members. The TWP Members have the power to elect two of Investors' Board Members. The TWP Members are Thomas Weisel Capital Partners, L.P., TWP CEO Founders Circle (QP), L.P., TWP CEO Founders Circle (AI), L.P., Thomas Weisel Capital Partners Employee Funds, L.P., TWP 2000 CO-Investment Fund, L.P., Thomas Weisel Capital Partners (Dutch), L.P., and Thomas Weisel Capital Partners (Dutch II), L.P. The Class A and Class C membership interests described above are the only equity interests in Investors. Certain management level employees of Investors' subsidiaries have been issued Class B membership interests in Investors and, under certain circumstances, distributions to Investors' members can include distributions to the Class B members. The Class B members can vote on whether to add new Class B members. Otherwise, their status as Class B members does not give them any managerial power over Investors business. All Class B members are United States citizens and none has attributable media interests outside of the attributable media interests held by Investors. The Class B members are Carl Hirsch, Steven Dinetz, Samuel Weller, Jeffrey Dinetz, Sean Stover, Steven Smith, Matthew Leibowitz, Allen Stieglitz, James Matalone, Scot McArtor, Michael Morrill and Bruce Washburn.
