Dear Mr. Wood:

This is in reference to the request filed on December 30, 2015. WLP requests an extension of the STA granted on October 15, 2015, to operate station WYEL(AM) with temporary facilities using tower #2 of the array due to storm damage to the tower #1 antenna tuning unit.¹ In support of the request, WLP states that an additional 90 days is needed to complete repairs and resume licensed operations.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

WLP must file an FCC Form 302 application after all repairs have been completed in order to update all operating parameters. Otherwise a one page letter must be filed to the attention of supervisory engineer Son Nguyen certifying the date the station resumed licensed operations with no



noticeable changes to the operating parameters, along with a copy of the most recent license (BL-19991104ABQ) for reference.

Accordingly, the request for extension of STA IS HEREBY GRANTED, and station WYEL(AM) may continue to operate ND from tower #2 of the array and with a power not to exceed 1.25 kW. It will be necessary to further reduce or cease operation if complaints of interference are received. WLP must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **April 27, 2016**.
