

Multiple Ownership Study

The following engineering statement and attached exhibits have been prepared for Three Eagles Communications, and contain a multiple ownership study relative to the acquisition of three authorizations in the Fort Dodge, Iowa area.

Currently, Three Eagles is the licensee of four broadcast facilities in the vicinity of Fort Dodge. Of these four facilities, three are commercial FM stations, while the remaining station is an AM facility. Specifically these stations are KIAQ(FM) at Clarion, Iowa, KTLB(FM) at Twin Lakes, Iowa, and KUEL(FM) and KVFD(FM) both at Fort Dodge, Iowa. It is proposed that Three Eagles acquire KKEZ(FM) and KWMT(AM both at Fort Dodge, Iowa as well as a construction permit for a new station (BMPH-20060804AEO) at Manson, Iowa.

The location each of the facilities involved is outside of an Arbitron rated market. As a result, the contour methodology will be employed to demonstrate that the proposed acquisition of the three facilities in question would be in compliance with the provisions of Section 73.3555 of the Commission's Rules. Due to the location of the principal community coverage contours of each of the facilities involved, two different contour markets would be established.

The first of these two markets involves the common overlap between KIAQ(FM), KTLB(FM), KVFD(AM), KKEZ(FM), BMPH-20060804AEO, and KWMT(AM). The second of the markets is comprised of the common overlap between KIAQ(FM), KUEL(FM), KVFD(AM), KKEZ(FM), BMPH-20060804AEO, and KWMT(AM). Each market would be comprised of the common overlap between six facilities, four of which are in the same service. The first map in this study illustrates the facilities involved in the multiple ownership situation and the markets to be analyzed.


Since the first market involves six facilities, four of which are in the same service, it is necessary and sufficient to demonstrate that there are at least fifteen facilities serving the market. The second map in this study, which demonstrates the analysis of this market, illustrates the principal community coverage contour for an additional twelve facilities. As a result, it is sufficiently demonstrated that at least fifteen facilities serve the market as a total of eighteen facilities have been indicated on the relevant map. This market is therefore in compliance with Section 73.3555 of the Commission's Rules. Each of the other facilities considered has a transmitter site located within 92 kilometers of the perimeter of the common overlap area.

In the case of the second market, six facilities are also involved, and four of them are in the same service. As was the case with the first market, it also is

necessary and sufficient for this market to demonstrate that at least fifteen stations serve the market. The third map in this study analyzes this market and illustrates the principal community coverage contour of twelve additional facilities. Since at least eighteen facilities would serve the market, it is also evident that this second market would be in compliance with the provisions of Section 73.3555 of the Commission's Rules. Each of the other facilities considered has a transmitter site that is located less than 92 kilometers from the perimeter of the overlap area defining the market.

Since both constituent markets would be in compliance with the provisions of Section 73.3555 of the Commission's Rules, it is respectfully submitted that the proposed acquisition of the three authorizations in question would be in compliance with Section 73.3555 of the Commission's Rules. The preceding statement and attached exhibits was prepared by me, or under my direction, and is true and accurate to the best of my belief and knowledge.










