TECHNICAL STATEMENT

1. This technical statement and attached exhibit were prepared on behalf of Alpine Broadcasting Corp., Inc. ("Alpine"), licensee of station WAVV, Channel 266C1, Marco, Florida. Alpine is submitting a minor change application for WAVV to change the city of license to Naples Park, Florida. As such, a radio market analysis is necessary. WAVV's new community of license is located in a metro county in the Ft. Myers-Naples, Florida Arbitron Market (Market #62). As such an analysis for a rated market is needed.

ARBITRON/BIA MARKET REVIEW

2. As shown on Exhibit #1, there are thirty-seven AM and FM (commercial and non-commercial) stations listed in the Ft. Myers-Naples, Florida. Alpine would be in control of one FM station in the market. The number of stations indicated falls in the thirty to forty-four stations tier of §73.3555(a)(1)(ii) of the Commission's rules. At this level, common ownership or control of up to seven stations, with no more than four in the same service, is permissible. Therefore, control of WAVV in the Ft. Myers-Naples, Florida market is believed to be in compliance with the Commission's radio ownership rules for rated markets.

3. As a result of the compliance shown above, in the rated market, the minor change for WAVV is in compliance with the Commission's rules.

4. The foregoing technical statement was prepared on behalf of Alpine Broadcasting Corp., Inc., by Graham Brock, Inc., its Technical Consultants. All information contained herein is true and accurate to the best of our belief and knowledge. All data relating to AM and FM facilities in the relevant BIA/Arbitron market was determined using the BIA Financial Network, Inc. Media Access Pro, Version 4.2. BIA database. All other data was extracted from the CDBS database. We assume no liability for errors or omissions in either database which may be adverse to the information contained herein.


