Re: Notice of Early Exercise with respect to Call Option to acquire stations WIWB(TV), Green Bay-Appleton, Wisconsin, and WBDT(TV), Dayton, Ohio and Notice of Assignment with respect to right to acquire Designated Assets of station WBDT(TV), Dayton, Ohio

Dear Mr. Gealy:

Option Agreement. Reference is made to that certain Option Agreement by and between LIN Television Corporation (“*LIN*”) and ACME Television, LLC, ACME Television of Ohio, LLC, ACME Television Licenses of Ohio, LLC, ACME Television of Wisconsin, LLC, ACME Television Licenses of Wisconsin, LLC, ACME Television of New Mexico, LLC, and ACME Television Licenses of New Mexico, LLC, dated as of May 28, 2010, as amended (the “*Option Agreement*”). Capitalized terms not otherwise defined herein shall have the meaning ascribed thereto in the Option Agreement.

Notice of Early Exercise. This letter shall constitute the Exercise Notice of LIN, pursuant to Sections 2.3, 3.3 and 10.3 of the Option Agreement, evidencing its Early Exercise of the Call Option with respect to those certain Optioned Assets corresponding to the Dayton Station and the Green Bay Station pursuant to the terms and subject to the conditions of the Option Agreement.

Notice of Assignment with respect to Dayton Station. This letter shall also constitute notice by LIN, pursuant to Sections 10.3 and 10.5 of the Option Agreement, that in connection with, and immediately upon, the foregoing Early Exercise, LIN assigns to WBDT Television LLC, a Qualified Assignee under Section 10.5 of the Option Agreement, its right to purchase the portion of the Optioned Assets constituting the Designated Station Assets solely with respect to the Dayton Station pursuant to the terms and subject to the conditions of the Option Agreement. Pursuant to Section 10.5, enclosed please find a copy of the executed Assignment Agreement, dated as of the date hereof, by and between LIN and such Qualified Assignee evidencing the above-referenced assignment.

Assignment Application. In accordance with the foregoing and the Option Agreement, our counsel will be in touch with your counsel with respect to the Assignment Application with respect to the Green Bay Station and, we understand that counsel for the Qualified Assignee will be in touch with your counsel to coordinate with respect to the preparation and filing of the applicable Assignment Application concerning the Dayton Station.
