

Last WILL & TESTAMENT

Either one (1) of my herein named Executors, or all as Co-Executors, as and however agreed upon by and between the three (3) of them, shall serve without the necessity of making an inventory, appraisal or accounting.

I direct that my Executrix or Alternate Executors shall pay all medical expenses in connection with my last illness, all my funeral expenses and all my just debts which may be probated, registered and allowed against my estate, and all administrative costs, insofar as my assets will allow, as soon after my death as may conveniently be done.
