

## MUTUAL CONSENT AGREEMENT

This Mutual Consent Agreement (the "Agreement") is made as of July 17, 2007 by and between Santa Fe Community College ("SFCC"), and EDUCATIONAL MEDIA FOUNDATION ("EMF").

WHEREAS, EMF and SFCC desire to jointly consent to mutual contingent minor changes to the facilities of their stations, KQRI(FM), Belen, New Mexico and KSFR(FM), Santa Fe, New Mexico, respectively.

NOW THEREFORE, for good and valuable consideration, the receipt and adequacy of which is acknowledged by the parties, and upon the mutual promises and covenants made herein, the parties hereto agree as follows:

1. EMF hereby agrees to request a minor modification of its KQRI(FM) licensed facilities to move to a new tower site and upgrade to 7kw contingent upon SFCC's agreement to modify KSFR's licensed facilities to move to a new tower site and upgrade to 20kw.
2. SFCC hereby agrees to request a minor modification of its KSFR(FM) licensed facilities to move to a new tower site and upgrade to 20kw contingent upon EMF's agreement to modify KQRI's licensed facilities to move to a new tower site and upgrade to 7kw.
3. The parties hereby agree to coordinate and concurrently file with the FCC an application to modify the facilities of their respective facilities. EMF and SFCC agree that other than the exchange of promises, no other consideration, including monetary consideration, will be due to or from either party as to the actions contemplated by this Mutual Consent Agreement.
4. Each party agrees that no change in facilities shall be effectuated by either party unless and until the FCC has granted both parties' applications for the above-referenced changes.


