CHANGES IN INTEREST

Transaction. The instant application proposes the *pro forma* assignment of full-power commercial television Station WTVD(TV), Fresno, California (the “Station”) from ABC, Inc. (“ABC”) to WTVD Television, LLC (“WTVD LLC”). WTVD LLC is a wholly-owned subsidiary of ABC. No other ownership changes are proposed.

Structural Charts. Figure A shows the current ownership structure of the Station, while Figure B shows the proposed ownership structure of the Station.

Qualification for Pro Forma Treatment. As shown in Figures A and B, the current licensee, ABC, and the proposed assignee, WTVD LLC, both are controlled by the same entities. Ultimately, the Walt Disney Company controls both entities.

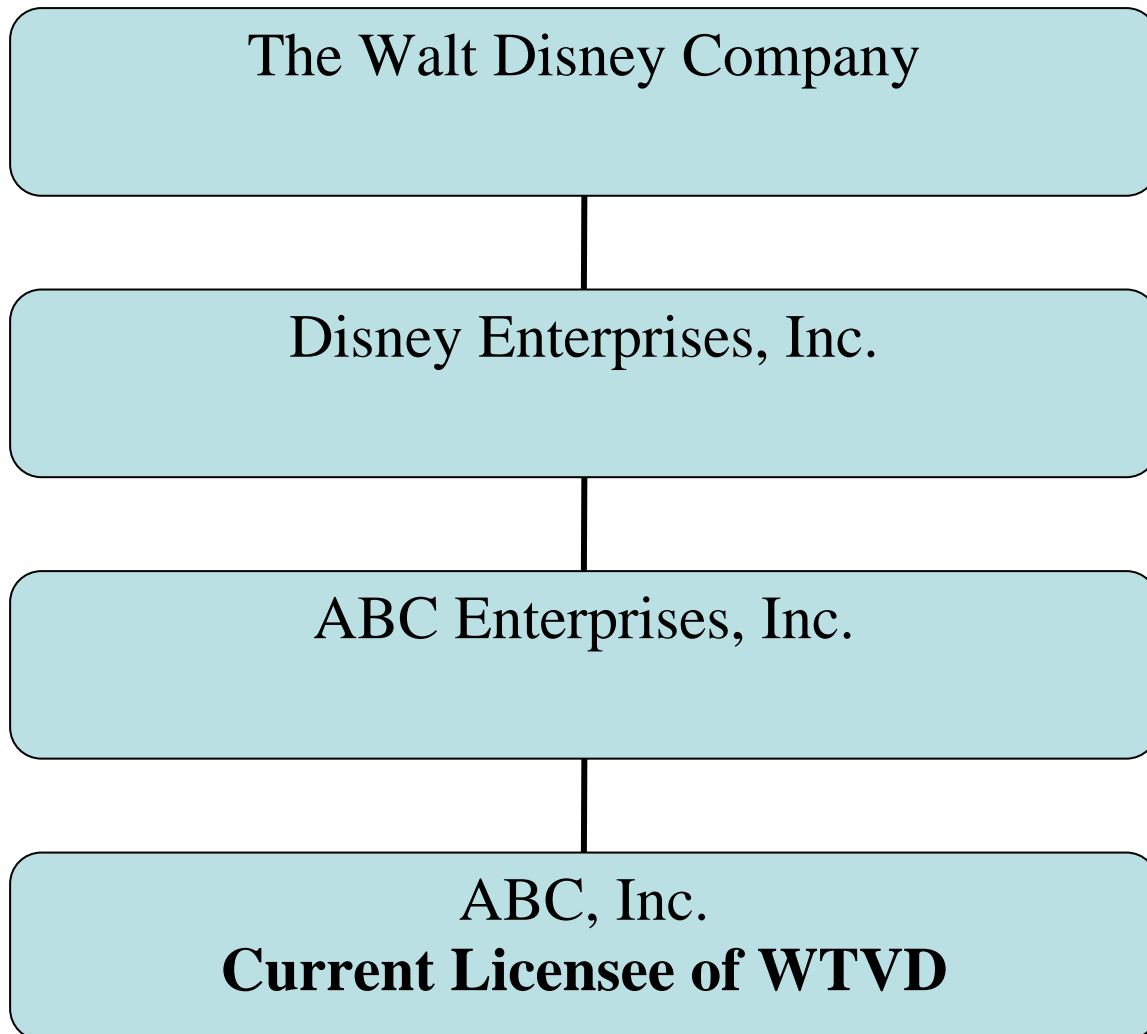
