STATEMENT DEALING WITH OMITTED SCHEDULES/RELATED AGREEMENT

Capstar Radio Operating Company, Capstar TX Limited Partnership, Red Wolf Broadcasting Corporation and Aloha Station Trust, LLC have entered into an Asset Purchase Agreement (the "Agreement"), providing for the purchase and sale of the assets of Station WURH(FM), subject to the consent of the Federal Communications Commission to the assignment of the Station's FCC licenses. A copy of the Agreement is provided as part of this Exhibit to FCC Form 314. Copies of the Schedules to the Agreement and related agreement have been omitted to avoid burdening the Commission with unnecessary information that is not relevant to the Commission's or the public's review of the transaction proposed herein and to preserve proprietary information relating to the business of the parties to the Agreement. The New York Attorney General has issued subpoenas to Seller and certain other radio companies requesting information on policies and practices regarding record promotion, and has entered into settlement agreements with major record labels and two radio companies. Seller is cooperating with that investigation. The FCC also initiated an investigation into compliance with its sponsorship identification rules. The FCC sent letters of inquiry to Seller and other radio companies on that subject. On April 13, 2007, the FCC released Consent Decrees which it entered into with Seller and three other radio companies. Each Consent Decree includes, among other things, a voluntary monetary payment to the US Treasury, and a Compliance Plan and Business Reforms intended to prevent future violations. No admissions were made of any violation of law. In addition, separately from the Consent Decrees, Seller and the other radio companies voluntarily elected to devote specified amounts of airtime to local and regional music and music of unsigned artists and artists affiliated with independent labels, and endorsed certain “rules of engagement” governing interaction with record labels.
