Re: Petition to Deny License Renewals of Hispanic Christian Community Network, Inc.

Dear Mr. Couzens:

On June 30, 2014, you filed a Petition to Deny (Petition) objecting to the grant of the applications for license renewal of the following low power television (LPTV) stations formerly licensed to Hispanic Christian Community Network, Inc. (HCCN):

- KSFW-LD, Dallas, TX (Fac. ID No. 130934), File No. BRDVL-20140401AAR
- K23IA, San Angelo, TX (Fac. ID No. 130496), File No. BRTTL-20140602AUG
- KJTN-LP, Abilene, TX (Fac. ID No. 127351) File No. BRTTL-20140401AAZ
- KZAB-LP, Abilene, TX (Fac. ID No. 130088), File No. BRTTL-20140401AAX
- KZOD-LP, Odessa, TX (Fac. ID No. 130504), File no. BRTTL-20140401AAV
- KHFW-LD, Dallas, TX (Fac. ID No. 130952), File No. BRDVL-20140401AAT
- KEAM-LD, Amarillo, TX (Fac. ID No. 131091), File No. BRDTL-20140401AAP
- KXCO-LD, Refugio, TX (Fac. ID No. 127994), File No. BRDTL-20140401AAN
- KFYW-LD, Wichita Falls, TX (Fac. ID No. 132692), File No. BRDTL-20140401AAL

The Petition at issue requests denial of these license renewal applications based on alleged misrepresentation and false certifications by Mr. Antonio Casear Guel concerning his citizenship. Mr. Guel was the 100% shareholder of HCCN. Specifically, the Petition discusses that as part of a court proceeding before the Los Angeles County Superior Court Mr. Guel stated, in writing, that he was not a U.S. citizen.¹ The Petition argues that not only does this answer conflict with certifications made in Commission applications,² but is also a violation of Section 310(b) of the Communications Act of 1934, which places restrictions on direct and indirect foreign ownership of broadcast licenses.³

As of November 30, 2016, the licenses of LPTV stations K23IA and KYWF-LD have been canceled.⁴ With regards to the remaining stations listed in the Petition, it has come to the attention of

Video Division (Division) staff that, at the time of application, the stations were no longer licensed to HCCN. According to Notices of Consummation filed by HCCN, the LPTV stations were licensed as follows:

- KEAM-LD, KZOD-LD, KXCO-LP, and KSFW-LP, were licensed to De Mujer A Mujer International (De Mujer);⁵
- KZAB-LP and KTJN-LP were licensed to Jennifer Juarez;⁶ and
- KHFW-LD and KZHO-LD were licensed to Iglesia Manmin Toda La Creacion USA Inc. (Iglesia).⁷

While the information provided in the Petition raises significant legal questions, in light and the facts and circumstances discussed above, we are unable to provide the relief requested by the Petition. Not only have two of the applications been dismissed due to license cancellation, but the others were not licensed to HCCN or Mr. Guel.⁸

Accordingly, the Petition to Deny filed against the above listed applications for license renewal **IS DISMISSED**. Furthermore, on July 21, 2014, you filed a request for withdrawal of the Petition. In light of the findings above, the Request for Withdrawal **IS DISMISSED** as moot. Our action should not be interpreted as a finding of fact or law regarding the substantive claims raised in the Petition. We retain the right to initiate, on our own motion, an investigation into the matters raised.
