1. For the reasons explained in the attached Exhibit 4 from the concurrently filed pro forma insubstantial transfer of control application (Form 316) of Trinity Christian Center of Santa Ana, Inc., d/b/a Trinity Broadcasting Network (“Trinity”), Trinity Broadcasting of New York, Inc. (“TBNY”), an affiliated non-profit church ministry organization of Trinity, is also seeking approval for a pro forma insubstantial transfer of control.<sup>1</sup> While three of Trinity’s (and TBNY’s) current board members – Dr. Paul F. Crouch, Mrs. Janice Crouch, and Paul Crouch, Jr. – have been approved in long form applications, it may be that this short form application is not required – one new director out of four represents only a 25% voting interest. Nevertheless, out of an abundance of caution, TBNY (and Trinity) believes it is appropriate to obtain Commission approval for the addition of a fourth board member, Mr. Matthew Crouch.

2. Should the Commission or the Bureau Staff believe any additional information is necessary, it will be promptly provided.

1. Trinity Christian Center of Santa Ana, Inc., d/b/a Trinity Broadcasting Network (“Trinity”) is seeking approval for a pro forma insubstantial transfer of control.<sup>2</sup>

2. Trinity is a non-profit church corporation with a self-perpetuating board of directors. It has historically had only three directors, which are currently Dr. Paul F. Crouch, Sr., Mrs. Janice W. Crouch, and Paul Crouch, Jr. Trinity’s President, Dr. Paul F. Crouch, Sr. has been a director since Trinity was first formed on August 2, 1973. Mrs. Janice W. Crouch, Dr. Crouch’s wife, has also been a director for approximately two decades (*e.g.*, BRCT-19880729KG, granted November 23, 1988). Both have repeatedly had their qualifications approved by the Commission in various assignment<sup>3</sup> and renewal applications.<sup>4</sup>

3. In 2003 Paul Crouch, Jr., became a director of Trinity (BOA-20030730ANI). Since then his qualifications have also been approved in the long form transfer of control application for WGTW-TV, Burlington, N.J. (BTCCT-20040803ABW, granted September 16, 2004), and in the long form assignment for WTGL-TV, Cocoa, Florida (BALCT-20060620ABJ, granted August 1, 2006), and in the renewal applications listed in paragraph 7, *infra*.

4. At a May 15, 2007 board meeting, Mr. Matthew Crouch was elected to the Trinity board of directors, contingent upon, to the extent necessary, Commission approval. Trinity is therefore submitting this pro forma insubstantial transfer of control application (Form 316) pursuant to the Commission's *Transfer of Control of Certain Licensed Non-Stock Entities*, 4 FCC Rcd 3403, FCC 89-90 (released April 11, 1989). The Commission has explained that "a majority change in a self-perpetuating board, which arises from a gradual transition of board members, [is] an insubstantial transfer of control," *Id.* at ¶26 (footnote omitted), and "insubstantial transfer of control . . . approval must be sought on an FCC Form 316 (short form) application." *Id.* at ¶29(b)

5. Because the qualifications of all three of Trinity's current board members, without regard to Matthew Crouch, have been approved in long form applications, as noted above, it may be that this short form application is not required – one new director out of four represents only a 25% voting interest. Nevertheless, out of an abundance of caution, Trinity believes it is appropriate to obtain Commission approval for the addition of Matthew Crouch as a fourth board member.

6. In addition, Matthew Crouch's board membership, coupled with that of Paul Crouch, Jr. and not considering that Paul Crouch, Jr.'s qualifications have been previously approved, could possibly be viewed as triggering a negative transfer of control. For a four person board, a negative transfer of control would occur if two members were either added or removed over a short period of time (here four years). However, Form 316 is also used "where two parties have negative control
