Dear Mr. Kennedy:

This is in reference to the request filed on March 24, 2021. SSB requests a further extension of the STA granted on July 30, 2020, to continue operating with parameters at variance to allow time to detune cell towers adjacent to the transmitter site.<sup>1</sup> In support of the request, we noted that Entercom stated that additional time will be needed to complete the detuning work.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of the STA IS HEREBY GRANTED, and Entercom may continue to operate with DA parameters at variance and reduced power if needed to stay within licensed limits. Entercom must reduce power or cease operation if complaints of interference are received, and use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR §1.1310. Entercom must submit an e-mail to my attention to note the date the station resumed licensed operations per BMML-20140314ADY with negligible changes, or to note the date an FCC Form 302

application was filed to make any necessary changes to the operating parameters.

This authority expires on **October 21, 2021**.
