TECHNICAL STATEMENT

1. This technical statement and attached exhibits were prepared on behalf of Telesouth Communications, Inc. ("TCI"), licensee of stations WOEG, 1220 kHz, and WDXO, Channel 225A, Hazlehurst, Mississippi. TCI is submitting applications to modify the facilities of WOEG and WDXO. As such an updated radio market analysis is needed. TCI is also the licensee of WRQO, Channel 271C2, Monticello, Mississippi.¹ Neither WOEG, WDXO or WRQO are licensed to communities located in any Arbitron Market, nor are they designated "home" to any Arbitron/BIA Market. As such, a contour overlap ownership analysis is needed. Exhibit #1 is a map depicting the city grade contours of the subject stations. As is noted on the map, the proposed WOEG, proposed WDXO and authorized WRQO contours have a common area of overlap.

2. A study has, therefore, been conducted to verify that the ownership of these stations is in compliance with the Commission's multiple ownership rules. The city grade contours of the stations will be used to determine the number of other stations in the market. No stations with transmitters located more than 92.0 kilometers from the boundary of the common overlap of

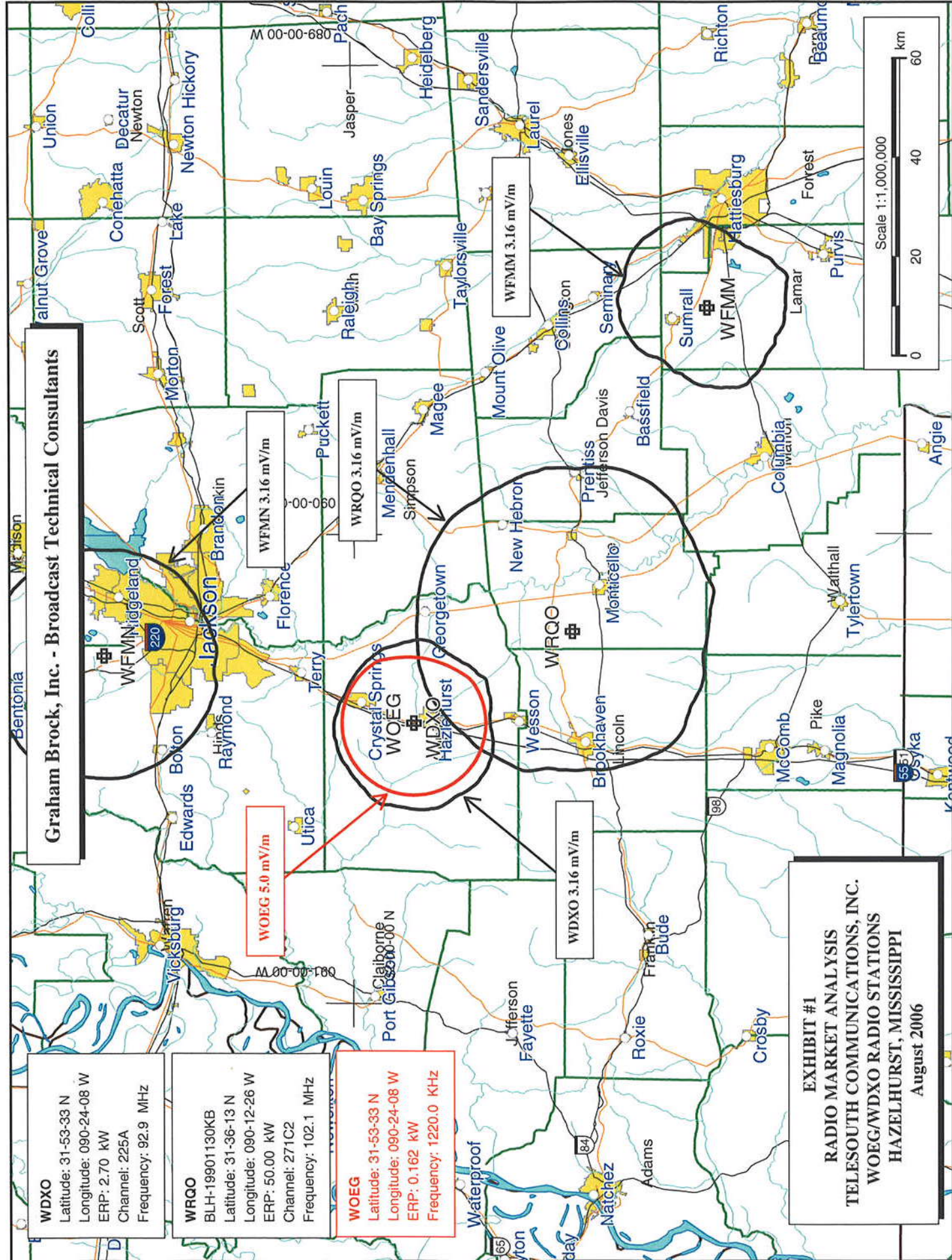
1) TCI has interests in other nearby stations. The closest to the Hazlehurst/Monticello, Mississippi area are stations WFMN, Channel 247C3, Flora, Mississippi and WFMN, Channel 247A, Sumrall, Mississippi. Neither WFMN or WFMM overlap with WOEG, WDXO or WRQO. As such, no other TCI facility impacts this instant market analysis.

subject stations will be considered. Nor will any TCI station be considered as a contributing station unless it is a subject station in the market under review.

3. Exhibit #2 is a depiction of the AM and FM stations, commercial and non-commercial, providing service to the Radio Market. Exhibit #3 is a tabulation of the stations in Radio Market, a total of eight, including the three subject stations. The number of stations depicted falls in the fourteen or fewer stations tier of §73.3555(a)(1)(iv) of the Commission's rules.² At this level, common ownership or control of up to five stations, with no more than three in the same service, is permissible provided the number of stations to be commonly held does not exceed 50% of the stations in the market. Based on this number of facilities, it has been herein demonstrated that the Radio Market is in compliance. Based on the above, it has been shown that the minor change applications for WOEG and WDXO are in compliance with the Commission's ownership rules.

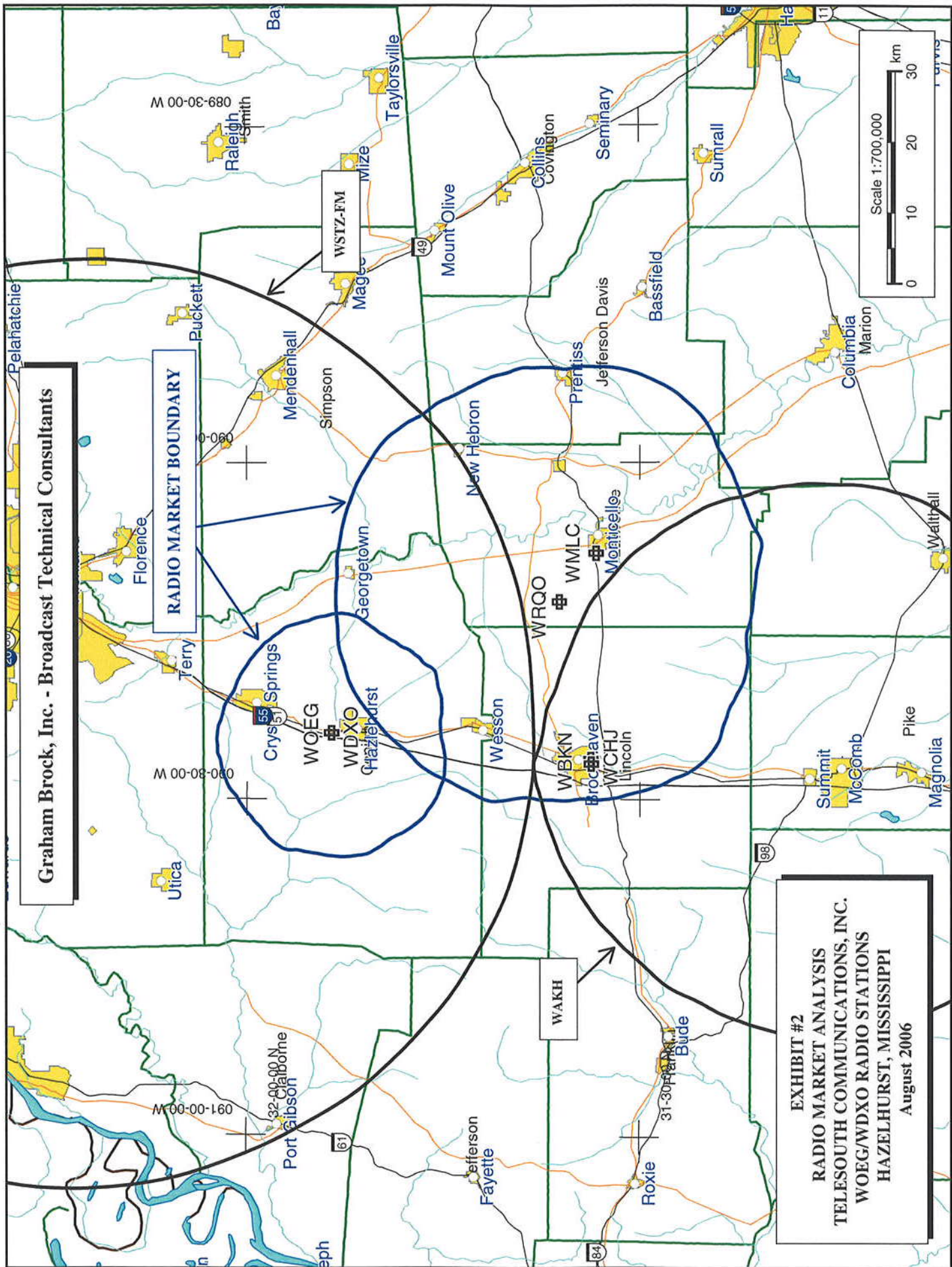
