SUPPLEMENT


Simmons-SLC, LS, LLC ("Simmons"), licensee of KJQN(FM), Brigham City, Utah, by its counsel, submits this supplement to its counterproposal filed yesterday in the above-captioned proceeding, addressing three minor matters. First, Paragraph 1 of the counterproposal erroneously stated that an order to show cause would be necessary to the licensee of KBYI, Rexburg, Idaho. As the pleading makes clear, the Rexburg station is not affected. Paragraph 1 should be stricken from the counterproposal. Second, the table in paragraph 3 erroneously listed a channel change at Aberdeen, Idaho. Again, the pleading makes clear that the Aberdeen allotment is unaffected, and that table entry should be stricken from the counterproposal. Third, the certificate of service erroneously omitted one party upon whom a copy of the counterproposal was properly served. A corrected certificate of service is attached.


