

**INTEREST CHANGES – TRANSFER OF CONTROL  
FROM THE OLD BOARD OF PENSACOLA CHRISTIAN COLLEGE  
TO THE NEW BOARD OF PENSACOLA CHRISTIAN COLLEGE**

**PENSACOLA CHRISTIAN COLLEGE, INC.** (“*PCC*”), is the licensee of Radio Stations WPCS (NCE-FM), Pensacola, Florida (FCC Facility ID No. 52230), and KPCS (NCE-FM), Princeton, Minnesota (FCC Facility ID No. 93446). **PCC** also is an institution of higher learning with headquarters located in Pensacola, Florida, as well as a 501(c)(3) non-profit educational organization with a religious mission. The transfer of control that is subject of this application is the result of the selection of several new directors and the term-ending or retirement for other directors. The changes in the Board of Directors have occurred in the ordinary course of affairs for **PCC** and have been such that the majority of the new board will consist of persons who previously have not been passed upon by the Commission. Hence, the reason for this application.

No consideration at all has been promised or paid in connection with this transfer of control of **PENSACOLA CHRISTIAN COLLEGE, INC.** **PCC** will remain in control of WPCS and KPCS. The transfer of control reflected by this application is the result of the selection of several new directors and the term-ending or retirement for other directors. The changes in the Board of Directors (i) have occurred over time, in the ordinary course of affairs, for **PCC** and (ii) are such that the majority of the new board will consist of persons who previously have not been passed upon by the Commission. The requisite information concerning the legal qualifications of the new Board of Directors of **PCC** is submitted in **Exhibit 14** to this application. In alphabetical order, the (old) Board members, previously reported to the Commission, prior to any transfer,<sup>1/</sup>
