



## I

CBS Radio Stations Inc. (“Applicant”) is the licensee of WEAT-FM, West Palm Beach, Florida (Facility ID No. 29567). For purposes of the local radio ownership rule, WEAT-FM is deemed to be a part of the West Palm Beach-Boca Raton Arbitron Metro. WEAT-FM is licensed to West Palm Beach, Florida in Palm Beach County, which in turn is located in the West Palm Beach-Boca Raton Arbitron Metro. The attached exhibit was compiled on June 7, 2007 using BIA Research, Inc.’s *Media Access Pro* database. The exhibit lists all radio stations, including WEAT-FM, that are licensed to communities within the counties comprising the West Palm Beach-Boca Raton Arbitron Metro or that Arbitron designates as “home” to that Metro. The BIA report demonstrates that there are 30 full-power commercial and noncommercial radio stations in the West Palm Beach-Boca Raton Arbitron Metro.

Section 73.3555(a)(1)(ii) of the FCC’s rules provides that in a radio market between thirty (30) and forty-four (44) (inclusive) full-power, commercial and noncommercial radio stations, a single entity may not have a cognizable interest in more than seven (7) commercial radio stations in total and not more than four (4) commercial stations in the same service (AM or FM).

In addition to WEAT-FM, the Applicant also owns the following stations in the West Palm Beach-Boca Raton, Florida Arbitron Metro: WIRK-FM (Facility ID No. 1918), WNEW(FM) (Facility ID No. 24143), WMBX(FM) (Facility ID No. 25756) and WPBZ(FM) (Facility ID No. 1246) .

While Applicant’s ownership of five FM radio stations exceeds the same service limit established by Section 73.3555(a)(1)(ii), the Commission elected to “grandfather” existing combinations of radio stations in the *2002 Biennial Regulatory Review*, 18 FCC Rcd 13620, 13808 (“*Ownership R&O*”). Note 4 to Section 73.3555 (2003) provides that the local ownership rule will not be applied so as to require divestiture by any licensee of existing facilities, and will apply to an application for a minor change to an existing station only if a grant of such application would create new or increased concentration of ownership among commonly owned, operated or controlled media properties. Because grant of this application will not create any new or increased concentration of ownership among commonly owned, operated or controlled media properties, Applicant’s control of five FM radio stations in the West Palm Beach-Boca Raton Arbitron Metro remains “grandfathered,” and the local radio ownership limit of Section 73.3555(a)(1)(ii) is inapplicable.

## I

In its *Ownership R&O*, the Commission concluded that the radio-television cross ownership rule no longer served the public interest and repealed the rule. *Ownership R&O* at 13768. However, the Third Circuit's stay of the effective date of the FCC's multiple ownership rules imposed in 2003 remains in effect as to the repeal of the radio-television cross ownership rule. *See Prometheus Radio Project v. FCC*, 373 F.3d 372, 435 (3d Cir. 2004) (denying motion to lift stay of the radio-television cross ownership rule). The Applicant thus remains subject to the radio-television cross ownership rule.

The radio-television cross ownership rule is triggered when either (i) the Grade A contour of a television station encompasses the community of license of a commonly owned radio station, or (ii) when the 1 mV/m contour of an FM station or the 2 mV/m contour of an AM station encompasses the community of license of a commonly owned television station. Although the radio-television cross ownership rule is triggered by contour encompassment, the Commission determines compliance with the rule on an Arbitron Metro basis. In *Review of the Commission's Regulations Governing Television Broadcasting*, 16 FCC Rcd 1067, 1081 (2000), the Commission explained that it does not count toward an entity's radio-television cross ownership limit any radio station assigned to an Arbitron Metro other than to the Metro in which a commonly owned television station is licensed unless the contour of that distant radio station encompasses the community of license of the television station in question. *See also Shareholders of Hispanic Broadcasting Corporation*, 18 FCC Rcd 18834, 18837 n. 13 (2003).

Applicant's parent company, CBS Corporation, is the parent company of Channel 34 Television Station LLC, the licensee of television station WTVX-TV, Fort Pierce, Florida. WTVX-TV is located in the West Palm Beach-Ft. Pierce Designated Market Area, which encompasses the West Palm Beach-Boca Raton and Ft. Pierce-Stuart-Vero Beach Arbitron Metros. CBS Corporation is also the parent company of Miami Television Station WBFS Inc., licensee of WBFS-TV, Miami, Florida and CBS Television Stations Inc., licensee of WFOR-TV, Miami, Florida, which are located in the Miami-Fort Lauderdale, Florida Designated Market Area.

As demonstrated on Figure 1, the Grade A contours of WBFS-TV and WFOR-TV do not encompass the community of license of WEAT-FM. Furthermore, Figure 1 also shows that the predicted 1 mV/m contour of WEAT-FM will not encompass the community of license of either WBFS-TV or WFOR-TV. Therefore, the radio-television cross ownership rule is not triggered by the common ownership of WEAT-FM, WBFS-TV and WFOR-TV.

Figure 1 does demonstrate that the Grade A contour of WTVX-TV encompasses the community of license of WEAT-FM. Although the radio-television cross ownership rule is triggered by contour encompassment, the Commission determines compliance with the rule on an Arbitron Metro basis. WTVX-TV is located in the Ft. Pierce-Stuart-Vero Beach Arbitron Metro.

Under the radio-television cross ownership rule, an entity may control up to two commercial television stations and six commercial radio stations (to the extent permitted by the local radio ownership rule) or one commercial television station and seven commercial radio stations (to the extent that an entity would be permitted to own two commercial television stations and six commercial radio stations) in a market if at least 20 independently owned and operated media voices would remain in the market post acquisition. *See* 47 C.F.R § 73.3555(c)(2)(ii) (2002). As discussed above, the Applicant's control of five grandfathered radio stations in the West Palm Beach-Boca Raton Arbitron Metro (WEAT-FM, WIRK-FM, WNEW(FM), WMBX(FM) and WPBZ(FM)) complies with the local radio ownership rule. The Applicant also complies with the local radio ownership rule in the Ft. Pierce-Stuart-Vero Beach Arbitron Metro.

The Applicant currently has a cognizable interest in two commercial radio stations in the Ft. Pierce-Stuart-Vero Beach Arbitron Metro (WMBX(FM) and WPBZ(FM)). Attached is a copy of the BIA FCC Geographic Market Definition Report for the Ft. Pierce-Stuart-Vero Beach Arbitron Metro (compiled on June 7, 2007), which demonstrates that there are 25 full-power commercial and noncommercial radio stations in that Metro. Section 73.3555(a)(1)(ii) of the FCC's rules provides that in a radio market between fifteen (15) and twenty-nine (29) (inclusive) full-power, commercial and noncommercial radio stations, a single entity may not have a cognizable interest in more than six (6) commercial radio stations in total and not more than four (4) commercial stations in the same service (AM or FM). The Applicant's ownership with two FM stations in this Metro fully complies with the local radio ownership rule.

As the charts below indicate, there will be more than 20 independently owned and operated media voices in each of the West Palm Beach-Boca Raton Arbitron Metro and in the Ft. Pierce-Stuart-Vero Beach Arbitron Metro upon the grant of this application. Therefore, ownership of one television station and five radio stations in the West Palm Beach-Boca Raton Arbitron Metro, and one television station and two radio stations in the Ft. Pierce-Stuart-Vero Beach Arbitron Metro complies with the radio-television cross ownership rule.

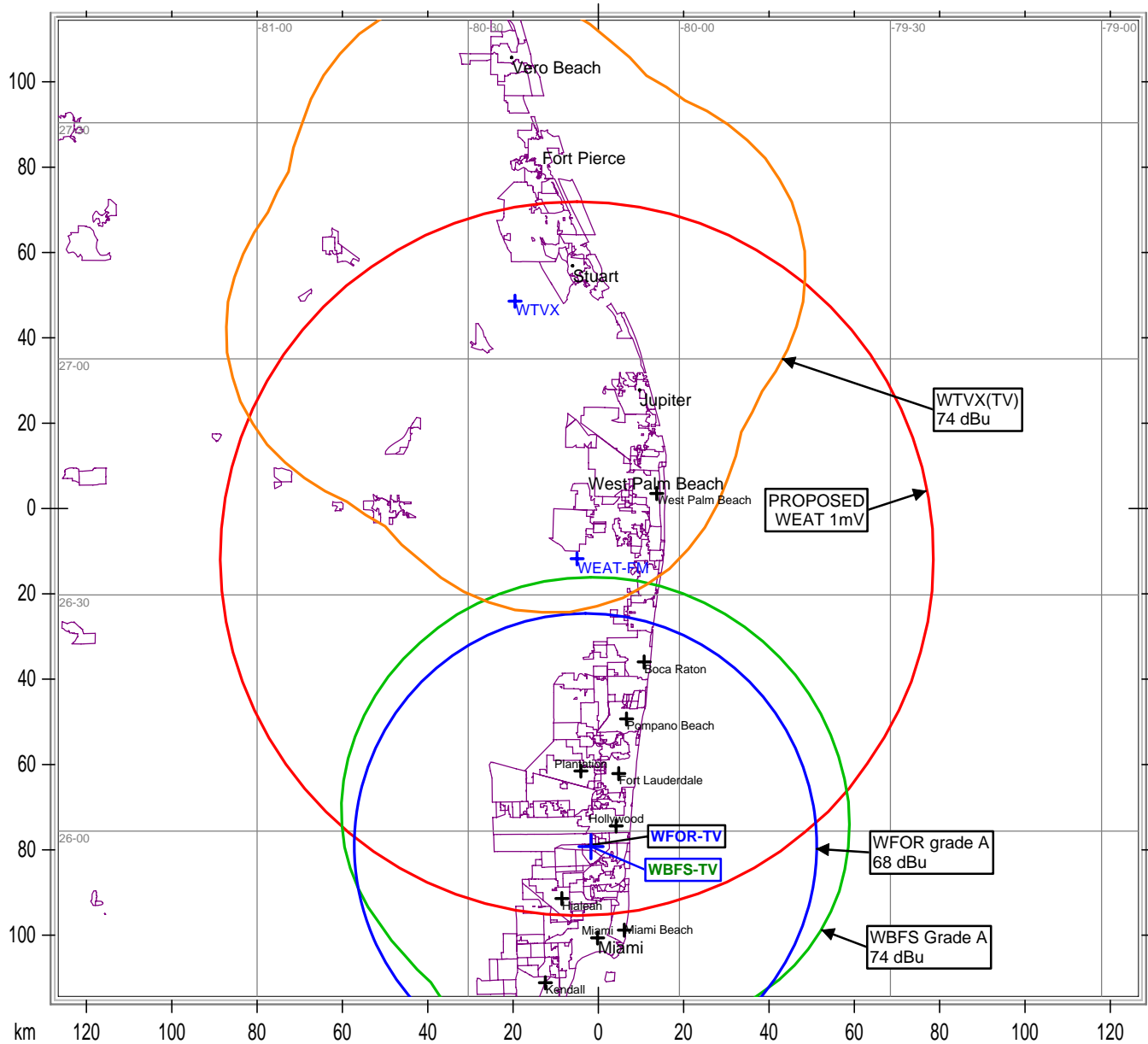
