Interference Area to WTCB
Columbia, South Carolina

The Proposed translator is within the 60 dBμ contour of upper third adjacent station WTCB channel 294. The WTCB interfering contour at the translator site is 81 dBμ F(50,50). Using the ratio of 100:1 (translator to WTCB) on the third adjacent channel, the population within the proposed translator 121 dBμ contour is zero. Using the antenna manufacturer's vertical radiation pattern the area of interference can be more accurately calculated geometrically than just by using the free space equation alone. This particular antenna is a one bay SWR FM1 antenna. It was determined from the manufacturer's vertical plan that at 45 degrees below horizontal the interference area would clear the ground by 16.0 meters. The antenna radiation center is 40 meters above ground, thus the interference area will never reach the ground. There are no occupied structures or elevated roadways within the interference area of the translator. Therefore, the application is in compliance with the following: §74.1204 (d) "The provisions of this section concerning prohibited overlap will not apply where the area of such overlap lies entirely over water. In addition, an application otherwise precluded by this section will be accepted if it can be demonstrated that no actual interference will occur due to intervening terrain, lack of population or such other factors as may be applicable."
