I, the undersigned natural person of the age of 18 years or more and a individual resident of the State of Texas, acting as the initial registered agent and incorporator of a corporation under Texas Non-Profit Corporation Act, do hereby adopt the following Articles of Incorporation for that corporation:

**ARTICLE ONE**

**ARTICLE TWO**

This Corporation is a non-profit corporation.

**Corporations Section**

**ARTICLE THREE**

The period of the Corporation's duration is perpetual.

**ARTICLE FOUR**

The purposes for which the Corporation is organized are:

- To lead people into living encounters with Jesus Christ through...
  - Worship- To love God (Matthew 22:36-37)
  - Community- love one another (John 13:34-35)
  - Outreach- To love our neighbors (Matthew 22:39)
- To have and exercise all authorizations, powers, rights, duties, and responsibilities now or in the future conferred on non-profit corporations under the laws of Texas.

The Corporation shall neither have nor exercise any power, nor engage In any activity, that would invalidate its status as an organization exempt from federal income tax and described in Section 501 ( c )(3) of the Internal Revenue Code of 1986, as amended, or the corresponding provisions of any subsequent United States internal revenue (the "Code").

No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation (except as permitted by Section 501 (h) of the Code), and the Corporation shall not participate or intervene in (including the publishing or distribution of Statements) any political campaign on behalf or in opposition to any candidate for public office.

**BYLAWS OF  
MISSION TEMPLO BETHEL INC  
(Texas Non-Profit Corporation)**

**ARTICLE ONE**  
*NAME, PURPOSE, POWERS, AND OFFICES*

**Section 1 Name:** The name of the organization is  
**MISSION TEMPLO BETHEL INC.**

**Section 1.2 Purpose:**

**MISSION TEMPLO BETHEL INC.,** is organized exclusively for charitable, religious and education purposes: with-in the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986, as amended, or the corresponding provision (s) of any successor Internal Revenue law or laws (the “code”).

The purpose of **Mission Templo Bethel Inc.,** is:

- To lead people into living encounters with Jesus Christ through...
- Worship – To love God (Matthew 22 : 36- 37)
- Community – To love one another (John 13 : 34-35)
- Outreach – To love our neighbors (Matthew 22 : 39)
- We believe in one God. (Deuteronomy 6:4).
- We believe in the unity of God. One Lord, one faith, one baptism. (Ephesians 4: 5).
- We believe in baptism in Jesus Christ Name. (Acts 2: 38).
- We believe in living holy for God. (1 Peter 1: 16).
- Marriage – Should be between a man and a woman only (1Corinthians 7:2; 10-11)
- To have and exercise all authorizations, powers, rights, duties, and responsibilities now or in the future conferred on non-profit corporations under the laws of Texas.

**Section 1.3 Powers:**

**Mission Templo Bethel Inc.,** (hereafter “**MTB**”) is non-profit corporation and shall have all of the powers, duties, authorizations, and responsibilities as provided in Texas Non-Profit Corporation Act. However, **MTB** shall neither have nor exercise any power, nor engage directly or indirectly in any activity that would invalidate its status as a corporation that is exempt from federal income tax as an organization described in Section (c) (3) of the Code.

**Section 1.4 Offices:**

**MTB** may have, in addition to its registration office, offices at such places, both within and without the state of Texas, as the Board of Directors may from time to time determine or as the activities of **MTB** may require.

**ARTICLE TWO**  
**BOARD OF DIRECTORS**

**Section 2.1 Directors/Members/Terms:**

The number of directors constituting the board of directors shall be three.

- (a.) One of the directors shall be the President of **MTB** (the “President Director”) who shall serve as a director as long as he or she serves as the President of **MTB**.

- (b.) The other two directors (the "Rotational Directors") shall initially be selected by the President Director/Founder of **MTB**. The Rotational Directors shall serve rotationally a three-year term and a five year term. Initially, as determined by the rotational directors, they will decide their comment term amongst themselves and then inform President Director for agreement. One will serve a three-year term and one will serve a five-year term. The Rotational Directors and their successors may not succeed themselves except by agreement between the President Director and the Rotational Director (not in Rotation term).
- (c.) **MTB** may (but need not) have voting members, and such membership, if any, and classes thereof, shall be as defined in **MTB** Bylaws. The management and affairs of **MTB** shall be at all times under the direction of a Board of Directors, whose operations in governing **MTB** shall be defined by statute and by **MTB** By-laws. No member or Director shall have any right, title, or interest in or to any property of **MTB**.

#### **Section 2.2 Terms of Office:**

- (a.) The President Director that hold office until earlier (i) a new President of **MTB** is elected and qualified or (ii) that director's death, resignation, and or retirement from office.
- (b.) Each Rotational Director of **MTB** shall hold office the earlier (i) the conclusion of the annual meeting of the Board of Directors marking the end of that director's rotational term as provided In Section 2.1(b) above and that director's successor is chosen and qualified or (ii) that director's death, resignation, retirement, disqualification, or removal from office.

#### **Section 2.3 Filling of Vacancy:**

Any Vacancy occurring in the Board of Directors resulting from death, resignation, retirement, disqualification, or removal from office of any director shall be filled in whatever manner the remaining directors choose to follow, whether by voting or by selection of agreement.

#### **Section 2.4 Removal:**

Any director may be removed, for or without cause, in the same manner that such director was elected in accordance with **MTB** Certificate of Formation and Bylaws, if notice of the intention to act upon such matter shall have been given in the notice of such meeting and if such notice is provided to the director proposed to be removed.

#### **Section 2.5 Place of Meeting:**


Meeting of the Board of Directors shall be held at such places, within or without the State of Texas, as may from time to time be fixed by the Board of Directors or as shall be specified or fixed in the responsive notice thereof.

#### **Section 2.6 Annual Meeting:**

An annual meeting of the Board of Directors, of which no notice shall be necessary, shall be held each year during January. At such annual meeting, the directors shall elect officers and transact any and all other business as may properly come before the meeting.

#### **Section 2.7 Regular Meeting:**

Regular meetings of the Board of Directors shall be held at Such times and places as may be fixed from time to time, by resolution adopted by the Board, and communicated by notice to all
