

This amendment addresses the following issues relevant to Section III, Item 4, Exhibit 11:

(1) The names of several entities identified in the exhibit have changed, as set forth below:

- Mark Ploof's title with respect to Four Points Media Group of Austin, Inc.; Four Points Media Group of Providence, Inc.; Four Points Media Group of West Palm Beach, Inc.; and Four Points Media Group of Salt Lake City, Inc. changed to Director, Vice President, and Chief Operating Officer.
- Mr. Ploof is Chief Operating Officer of Four Points Media Group LLC.
- Bradley R. Smith, a U.S. citizen, is Chief Financial Officer of Four Points Media Group of Austin, Inc.; Four Points Media Group of Providence, Inc.; Four Points Media Group of West Palm Beach, Inc.; Four Points Media Group of Salt Lake City, Inc.; and Four Points Media Group LLC. Mr. Smith's address is c/o Four Points Media Group of Salt Lake City, Inc., 299 South Main Street, Suite 150, Salt Lake City, UT 84111.

(3) Footnote 3 should read as follows: "All of the equity of TV Stations Investors LLC is held by US entities except for 8% which is held by a Bahamas entity. The amount of equity of the parent of each of Four Points Media Group of Austin, Inc.; Four Points Media Group of Providence, Inc.; Four Points Media Group of West Palm Beach, Inc.; and Four Points Media Group of Salt Lake City, Inc. attributable to non-US parties is less than 25 percent."

This amendment also addresses Section III, Item 6, Exhibit 15, as follows:

KUSG(TV), St. George, Utah (Facility ID No. 35822) currently operates as a satellite and 100% repeater of KUTV(TV), Salt Lake City, Utah (Facility ID No. 35823). Accordingly, when this application was originally filed, the proposed assignee, SLC TV Licensee Corp. ("SLC"), requested a waiver of the Commission's main studio rule, 47 C.F.R. § 73.1125, to permit satellite operation of KUSG(TV). Since filing the application, however, SLC has determined that it will develop KUSG(TV) into an independent TV station for the growing, yet underserved, St. George, Utah market. Accordingly, SLC respectfully withdraws its original waiver request and instead asks that the Commission condition grant of this application upon SLC's construction and operation, within 12 months of consummation of the assignment, of a main studio for KUSG(TV). The requested time will allow SLC to construct the main studio facility, procure the necessary equipment, staff the station, acquire programming, negotiate carriage agreements, and accomplish the numerous other tasks required to create a new and independent KUSG(TV).
