**Introduction**

This statement has been prepared on behalf of *Access.1 Pennsylvania License Company, LLC* (“Access.1”) to provide supplemental information to demonstrate compliance with Section 73.3555(a) of the Rules of the Federal Communications Commission as it governs common ownership of multiple radio stations serving the same market. *Access.1* is proposing to own seven stations in an area where it currently has no other attributable radio or television ownership interests:

As demonstrated below, *Access.1's* proposed holdings in the region lie in two geographic markets. Evaluation of the number of other radio stations in the markets shows that the proposed common ownership of these seven (7) stations in two geographic radio metro markets complies with §73.3555(a)(1) of the Commission’s Rules.

**FCC Radio Station Multiple Ownership Policy**  
**Arbitron Metro and Interim Contour Overlap Methodologies**

The Commission issued a *Report and Order* and *Notice of Proposed Rulemaking* (“*R&O*”)<sup>1</sup> for various multiple ownership and cross ownership issues. The *R&O* establishes a means of evaluating radio station multiple ownership issues utilizing existing Arbitron and BIA market data for markets with established geographic boundaries and a separate “interim” means for evaluating radio station multiple ownership issues beyond established Arbitron radio markets.

In this instant circumstance, all of the stations *Access. I* is proposing to acquire have principal communities of license in the Arbitron Metro Survey Area markets Allentown-Bethlehem, Pennsylvania or Wilkes Barre-Scranton, Pennsylvania.

The Allentown-Bethlehem, Pennsylvania Arbitron Metro Survey Area market is comprised of Carbon County, PA; Lehigh County, PA; Northampton County, PA; and, Warren County, NJ. Four of the proposed commonly owned stations (*two FM stations and two AM stations*) have communities of license within these counties and thus within the Allentown-Bethlehem, PA Metro:

The Allentown-Bethlehem Metro is identified by BIA as the home market for WEEX(AM), WTKZ(AM), WODE-FM, and WWYY(FM). The Wilkes Barre-Scranton Metro is identified by BIA as the home market for WSBG(FM), WPLY(AM), and WVPO(AM). Therefore, evaluation using the “interim contour-overlap” methodology is not warranted for *Access.I*’s proposed acquisition of these seven radio stations.

**Arbitron Metro Survey Area Market Analysis - Allentown-Bethlehem, PA Market**

**Attachment 1** to the instant engineering statement consists of BIA FCC Geographic Market Definition and Market Overview reports identifying the radio stations in the Allentown-Bethlehem, Pennsylvania Arbitron Metro Survey Area. Based on information prepared by BIA, there are 24 radio stations in the Allentown-Bethlehem, Pennsylvania Metro market.<sup>2</sup> *Access.I* is proposing to own two (2) AM stations and two (2) FM stations in the Allentown-Bethlehem market. The proposed common ownership of WEEX(AM), WTKZ(AM), WODE-FM, and WWYY(FM) meets the Commission’s rules for radio station multiple ownership, specifically, (§73.3555(a)(1)(iii)):

“§73.3555 Multiple ownership.

(a)(1) Local radio ownership rule. A person or single entity (or entities under common control) may have a cognizable interest in licenses for AM or FM radio broadcast stations in accordance with the following limits:

(iii) In a radio market with between 15 and 29 (inclusive) full-power, commercial and noncommercial radio stations, not more than 6 commercial radio stations in total and not more than 4 commercial stations in the same service (AM or FM);”

**Attachment 2** to the instant engineering statement consists of BIA FCC Geographic Market Definition and Market Overview reports identifying the radio stations in the Wilkes Barre-Scranton, Pennsylvania Arbitron Metro Survey Area. Based on information prepared by BIA, there are 49 radio stations in the Wilkes Barre-Scranton, Pennsylvania Metro market. *Access.1* is proposing to own two (2) AM stations and one (1) FM station in the Wilkes Barre-Scranton market. The proposed common ownership of WSBG(FM), WPLY(AM), and WVPO(AM) meets the Commission’s rules for Radio Station multiple ownership, specifically, (§73.3555(a)(1)(i)):

“§73.3555 Multiple ownership.

(a)(1) Local radio ownership rule. A person or single entity (or entities under common control) may have a cognizable interest in licenses for AM or FM radio broadcast stations in accordance with the following limits:

(i) In a radio market with 45 or more full-power, commercial and noncommercial radio stations, not more than 8 commercial radio stations in total and not more than 5 commercial stations in the same service (AM or FM);”

**Conclusion**

Based on the BIA FCC Geographic Market Definition and Market Overview reports for the Allentown-Bethlehem, Pennsylvania Arbitron Metro Survey Area there are at least twenty-four (24) stations listed as home to the Allentown-Bethlehem, Pennsylvania market. The proposed common ownership of WEEX(AM), WTKZ(AM), WODE-FM, and WWYY(FM) in the Allentown-Bethlehem, Pennsylvania Metro meets the Commission’s rules for radio station multiple ownership.

Similarly, based on the BIA FCC Geographic Market Definition and Market Overview reports for the Wilkes Barre-Scranton, Pennsylvania Arbitron Metro Survey Area there are at least forty-nine (49) stations listed as home to the Wilkes Barre-Scranton, market. The proposed common ownership of WSBG(FM), WPLY(AM), and WVPO(AM) in the Wilkes

Barre-Scranton Pennsylvania Metro meets the Commission's rules for radio station multiple ownership.

All of the proposed commonly owned stations have principal communities of license within Arbitron Metro Survey Areas and all are identified as home to those respective metros. Application of the interim, contour-overlap methodology is not warranted in this situation.

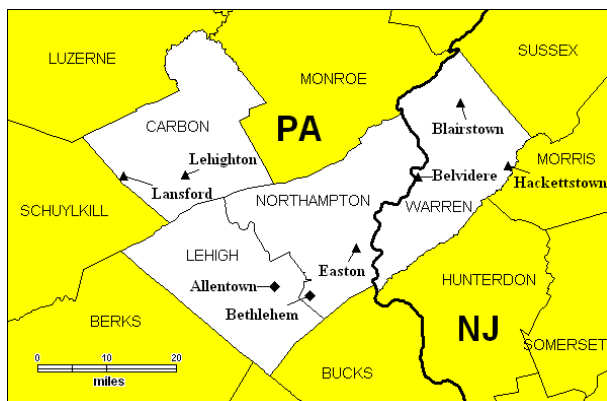

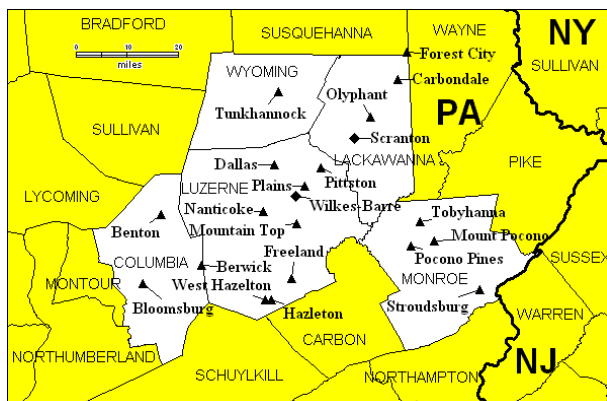
