

STATEMENT OF DISCREPANCY FOR STATION KVER-CA

Entravision Holdings, LLC (“Entravision”), the licensee of Station KVER-CA, Indio, California. (FIN: 69753), hereby submits that the relevant Database Technical Information for the Station, as found in the Schedule 381, is incorrect and requests that the Commission correct such information for the Eligible Facility.

The pre-populated Schedule 381 refers to the Database Technical Information as being derived from FCC File No. BLTVL-19900820IO. This is incorrect.

The Database Technical Information should be derived from the license in File No. BLDTL-20140623ABO, to cover the digital companion channel on Channel 41 for Station KVER-CA. In Appendix A to the *Public Notice*, DA 15-679, released June 9, 2015, the Media Bureau indicated that the appropriate File Number is File No. BLDTA-20140623ABQ, which is Entravision’s application for a license to convert the digital companion channel on Channel 41 to a Digital Class A Station, with the facilities licensed to Entravision in File No. BLDTL-20140623ABO. Either application provides the requisite information as to the Eligible Facility and evidences that the use of the information from File No. BLTVL-19900820IO was in error.

On June 23, 2014, Entravision submitted an application, in File No. BLDTL-20140623ABO, for a license to cover the construction permit in File No. BDISDTL-20130618AAY, which authorized a digital companion channel on Channel 41. *Public Notice*, Report No. 28290, released June 27, 2014. The application in File No. BLDTL-20140623ABO was granted on July 29, 2014. *Public Notice*, Report No. 48294, released August 1, 2014.

On June 23, 2014, Entravision submitted an application, in File No. BLDTA-20140623ABQ, to convert the digital companion channel, whose license was granted in File No. BLDTL-20140623ABO, to Class A Station status. *Public Notice*, Report No. 28270, released June 27, 2014. The application in File No. BLDTL-20140623ABQ was pending as of May 29,

2015. Consequently, KVER-CA, as of May 29, 2015, was operating in the digital mode with a pending application to convert its digital companion channel to Digital Class A status.

In that the digital operation of KVER-CA along with the submission of an application for conversion of the digital companion channel to Class A status occurred on or before the Pre-Auction Licensing Deadline of May 29, 2015, as provided for in *Media Bureau Designates May 29, 2015 as Pre-Auction Licensing Deadline*, 30 FCC Rcd 393 (MB 2015), the facilities specified in File Nos. BLDTL-20140623ABO and BLDTA-20140623ABQ should be considered as those of the Eligible Facility for Station KVER-CA. *Public Notice*, DA 15-679, released June 9, 2015.

Consequently, Entravision requests that the Commission change the applicable License Facility Number in determining the Eligible Facility for KVER-CA, from File No. BLTVL-1999020IO to BLDTL-20140623ABO (by virtue of the requested conversion of the digital companion channel to Class A status in File No. BLDTA-20140623ABQ).
