Form 381, Item 2

Pursuant to the procedures set forth in the *Incentive Auction Report and Order*, on May 28, 2015, American Broadcasting Companies, Inc. (“ABC”), licensee of full-power commercial digital television station WABC-TV, New York, New York (“WABC”), filed a letter with the Media Bureau of the Federal Communications Commission (“FCC”) electing protection for the facility at One World Trade Center authorized by FCC File No. BMPCDT-20080620AMV (“WABC World Trade Facility”).¹ On June 9, 2015, the Media Bureau released a public notice (“Notice”) announcing, *inter alia*, that the WABC World Trade Facility is eligible for protection in the repacking process and for relinquishment in the reverse auction.² The Notice directed licensees of eligible facilities to file FCC Form 2100, Schedule 381 (“Technical Certification Form”) by no later than July 9, 2015.

In accordance with the Notice, ABC has completed Item 1 of the Technical Certification Form to certify to the accuracy of the authorization and underlying Database Technical Information for the WABC World Trade Facility. Item 2 of the Technical Certification Form seeks certain specific information regarding the technical operations of eligible facilities. Because the WABC World Trade Facility has only recently been authorized in a construction permit and has not yet been constructed, ABC does not, at this time, have the information necessary to complete this portion of the Technical Certification Form for the WABC World Trade Facility. The only technical information regarding the WABC World Trade Facility is that set forth in the FCC’s databases and on the face of the construction permit for the WABC World Trade Facility. Thus, in accordance with informal staff advice, ABC has completed Item 2 of the Technical Certification Form based on its currently licensed facilities located at the Empire State Building (FCC File No. BLCDT-20121031ABC).

With respect to Item 2(c)(1), the currently licensed facilities located at the Empire State Building use a rigid transmission line with 10 feet section lengths. Because Schedule 381 does not contemplate 10 feet section lengths, WABC checked “Broadband/Varied Length feet” and is attaching this exhibit to provide the foregoing information.
