**ARTICLES OF AMENDMENT TO
SECOND RESTATED ARTICLES OF INCORPORATION
OF
KCTS TELEVISION,
A WASHINGTON NONPROFIT CORPORATION**

Pursuant to RCW 24.03.170 of the Washington Nonprofit Corporation Act, the undersigned corporation hereby submits the following amendment to the Corporation's Second Restated Articles of Incorporation:

1. The name of the corporation is KCTS Television, a Washington nonprofit corporation (hereafter the "**Corporation**").

2. The text of the amendment as adopted is as follows:

Article 1 is deleted in its entirety and amended to read:

**ARTICLE 1
NAME**

The name of this corporation is Cascade Public Media.

3. This Corporation has no members having voting rights with regard to the question of amending the Articles of Incorporation.

4. The amendment contained herein was duly adopted by unanimous consent of the directors currently in office on November 1, 2015.

5. These articles will be effective upon filing.
