Notification of Use of Virtual Channel 16**


Dear Mr. Hashemzadeh:

DTV America Corporation ("DTVA"), by its attorney, hereby notifies the Commission that digital low power television station WNCB-LD, Fayetteville, North Carolina (Facility No. 183629) presently is utilizing Channel 16 as its virtual channel.

The Commission originally assigned WNCB-LD to use Channel 15. However, DTVA has determined that utilizing Channel 15 would have led to impermissible contour overlap with co-channel and full-power television station WPDE-TV, Florence, South Carolina (Facility No. 17012) because WPDE-TV is using Channel 15 as its virtual channel. The contour map, attached hereto, depicts the extent of the predicted interference. Accordingly, consistent with the rules and policies of the Commission, DTVA is permitted to utilize the RF channel assigned to WPDE-TV (Channel 16) as the virtual channel for WNCB-LD and this letter provides notification to the Commission of such usage.

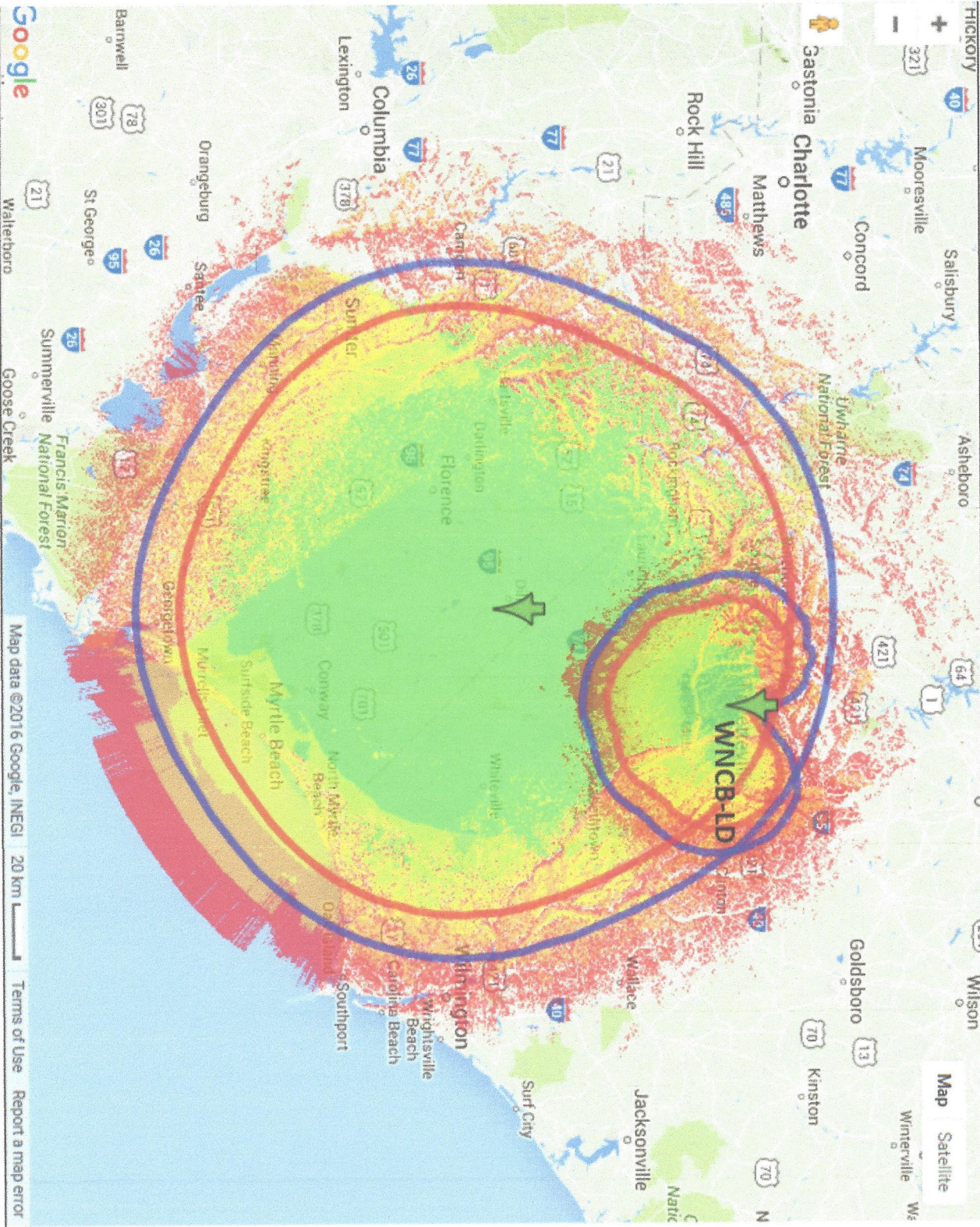
