

The applicant, licensee of WBSF(TV), seeks an special temporary authority (“STA”) to operate at (63% TPO or 1.26 kW) reduced power. As disclosed in the attached notice, the station experienced an amplifier failure which forced the station to reduce authorized power. The engineers estimate that repairs will take longer than 30 days. As a consequence, the applicant seeks STA to operate with reduced power until all repairs are completed.
