Activity: **SCHOLARSHIP PROGRAM**

WTAT-TV, Cunningham Broadcasting Corporation, established the FOX 24 WTAT-TV Scholarship at Trident Technical College (TTC). The scholarship was awarded to Tahirah Glover for the spring 2016 semester. According to TTC their "scholarship recipients reflect the diversity of TTC's student population. Recipients range in age from 17 to 74 with an average age of 34. Two thirds are female and one third are minorities. Six percent are veterans or active military". We will continue this scholarship annually to help students who are pursuing an associate degree in television broadcasting.

Activity: **INTERNSHIP PROGRAM**

The station also has an internship program as defined below:

Program Goal:

The goal of our internship program is to recruit students, primarily juniors and seniors, from colleges or universities and prepare them for entry-level jobs within the broadcast industry.

Program Objectives:

- Develop links with universities and colleges to promote Cunningham Broadcasting Corporation and its stations as prospective employers.
- Create a symbiotic relationship between interns and Cunningham employees.
