WITHDRAWAL OF PETITION TO DENY


1. New York Spectrum Holding Company (NYSHC) LLC hereby withdraws its Petition to Deny ("P2D"), filed on November 9, 2016, filed against the above-captioned application by Venture Technologies Group, LLC for a construction permit for a new digital companion channel for low power television station W42CX, Port Jervis, NY (the "Application").

2. The P2D stated that Application must be denied because it fails to protect from interference NYSHC's granted construction permit, CDBS File No. BDISDTL-20100421AAT, authorizing operation on Channel 22 by WXNY-LD, Facility ID 29231, New York, NY. The P2D was supported by an engineering statement describing predicted excessive unmasked interference.

3. Subsequent analysis has determined that the absence of a figure in a downloaded database analysis led to an inadvertent error in one of the inputs used in NYSHC's analysis. Correction of that input has led to the conclusion that proposal in the Application does not violate Section 74.710(a) of the Commission's Rules. Therefore, the basis for the P2D no longer exists.

4. In light of the foregoing, NYSHC hereby withdraws the P2D and states that it will interpose no objection to dismissal of the P2D.
