Re: Seal Rock Broadcasting, LLC, Licensee of KCBA(TV), Salinas, CA – Request for Waiver of the July 12, 2017 Filing Date to Submit the Form 2100 Construction Permit Application and Form 399 Repack Cost Estimate

Dear Ms. Dortch:

Seal Rock Broadcasting, LLC (“Seal Rock”), licensee of television station KCBA, Salinas, California, requests a waiver of the July 12, 2017 filing date for: (1) the Form 2100, Schedule A, Construction Permit Application, pursuant to 47 CFR § 73.3700(b)(1)(i), and (2) the Form 2100, Schedule 399.¹ The extraordinary circumstance which requires the submission of this request is the sudden death of Mr. George Kriste, one of the two managers of Seal Rock. Mr. Kriste dropped dead while hiking on Saturday, July 8, 2017. Mr. Kriste was the only member of Seal Rock involved in developing the information needed to submit the Construction Permit Application and Schedule 399. Seal Rock’s other member, Mr. Lance Anderson, up to this point, has received no information about the required filings and is unable to assist counsel in the preparation of those documents.

Seal Rock notes that such waiver requests were due by June 12, 2017. However, as demonstrated above, extraordinary circumstances exist for acceptance of this waiver request at this time.



As one can imagine, both Mr. Anderson and the Kriste family are devastated by this totally unexpected loss. Mr. Kriste's sudden death will impose many unplanned activities and matters upon Mr. Anderson and the Kriste family. Mr. Anderson and Seal Rock will move expeditiously to develop the required information and to submit the required filings.

In order to allow the orderly and thorough development of the required filings by Seal Rock, Seal Rock requests a 30-day waiver of the filing deadline to submit the Form 2100 Construction Permit Application and the Schedule 399. The above facts clearly demonstrate the existence of extraordinary circumstances and good cause for the requested waiver. The public interest will be well served by grant of the requested waiver.
