APPLICATION FOR CONSTRUCTION PERMIT - DISPLACEMENT

The following engineering statement and attached exhibits have been prepared for **Digital Networks-Southeast, LLC** ("Southeast"), licensee of analog low-power television station WWHL-LP at Decatur, Alabama, and are in support of their application for construction permit.¹ This application is being filed as a displacement application due to realignment of the television band resulting from the Commission's *Incentive Auction*. WWHL-LP qualifies to file in this application due its displacement resulting from the construction permit for WXPB-TV at Gadsden, Alabama on channel 33.² The licensed facilities for WWHL-LP would cause interference to WXPB-TV at a level in excess of that permitted under the Commission's Rules.

WWHL-LP is currently licensed to operate on channel 33 as an analog translator facility. The licensed effective radiated power is 11.3 kW at a center of radiation of 291 meters above mean sea level utilizing a directional antenna. The proposed facility would operate as a digital LPTV station on channel 31 with a maximum effective radiated power of 1.85 kW at a center of radiation of 280.5 meters above mean sea level utilizing a directional antenna. The proposed antenna is a Kathrein-Scala PR-TV-31 "paraflector" antenna. It is proposed that this antenna be oriented at 70 degrees true.

The proposed facility would be located at the licensed site for WWHL-LP. No change in the site location is proposed under this application. Exhibit E-1 provides the output from *TVStudy* for

the proposed facility. This study demonstrates no outgoing interference check failures for the proposed facility.

The proposed facility would not constitute a significant environmental impact, and is exempt from environmental processing. The proposed antenna would be mounted to an existing tower that is registered with the Commission. The addition of the antenna to this tower would not increase the existing environmental impact already present from the tower.

Using the equations in Supplement A of *OET Bulletin 65*, the calculated worst-case power density at ground level assuming a downward radiation relative field of 0.3 is $6.85 \mu\text{W}/\text{cm}^2$. This value is less than the upper limit of the uncontrolled environment condition. Southeast certifies it will coordinate with all other users of the site to ensure that workers and other personnel are not exposed to levels of radiofrequency radiation in excess of the applicable safety standards. Coordination activities will include, but are not necessarily limited to, a reduction in transmitter power or cessation of operation.

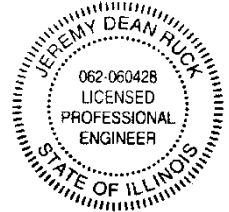
