West Central Ohio Broadcasting, Inc. ("WCOB") is the licensee of WOHL-CD, located in Lima, Ohio (Lima DMA), which is presently authorized to operate its digital facility on Channel 35. WOHL-CD has been assigned Ch. 15 for its post-incentive auction facility and has been assigned Phase 2 for the construction phase completion date (4/12/2019).

WOHL-CD is requesting a waiver and modification of its assigned transition phase to change its phase completion date from Phase 2 to Phase 5 (9/6/2019) for the reasons described in the waiver request which this statement supports.

The WOHL-CD facility is not linked with any other authorized station and its later transition will not negatively impact any other authorized station's transition. The proposed change from Phase 2 to Phase 5 will not create any new linked authorized station sets or result in impermissible interference with any other authorized stations as demonstrated by TVStudy 2.2 study.\(^1\)

Under the Transition Plan, there are only two authorized stations that will be transitioning in the Lima DMA. The proposed change from Phase 2 to Phase 5 would result in a second scan within the Lima, OH DMA which is acceptable since the FCC determined that up to two non-sequential rescans will serve the goals of efficiently clearing DMAs while minimizing viewer disruption. Therefore, WCOB's request to modify its phase assignment to permit WOHL-CD transition to its post-auction channel on or before September 6, 2019, satisfies the requirements for a waiver and will not have an adverse impact on the transition schedule or a negative impact on other authorized stations or viewers.
