

## **COMPLIANCE WITH MULTIPLE OWNERSHIP RULES**

Point Four, LLC (“Gold Coast”), the licensee of KOCP(FM), Oxnard, California, hereby demonstrates that the instant modification application fully complies with the Commission’s multiple ownership regulations.<sup>1</sup>

KOCP(FM) is “home” to the Nielsen Oxnard-Ventura radio market. Point Four is the licensee of two additional FM radio stations and three AM radio stations in the Nielsen Oxnard-Ventura radio market: KFYV(FM), Ojai, California; KCAQ(FM), Camarillo, California; KKZZ(AM), Port Hueneme, California; KVTA(AM), Ventura, California; and KUNX(AM), Santa Paula, California. Point Four has no attributable ownership interest, whether by ownership, LMA, or JSA in any other station in the Oxnard-Ventura market.

The most recent available Nielsen data for the Oxnard-Ventura radio market reveals that there are 20 commercial and noncommercial radio stations in the market. *See* the BIA FCC Geographic Market Definition for Oxnard-Ventura, attached hereto. Under the broadcast multiple ownership rules, in a radio market with between 15 and 29 commercial and noncommercial radio stations, an entity may lawfully own, operate, and control up to six radio stations, only four of which may be in one class. Accordingly, Point Four’s continued ownership of three FM stations and three AM stations in the market is fully compliant with the multiple ownership rules.<sup>2</sup>

KOCP is assigned to the Oxnard-Ventura Nielsen metro and Oxnard, KOCP's community of license, is physically located in the Oxnard-Ventura Nielsen metro market, which encompasses Ventura County. Accordingly, a modified contour overlap analysis is not required.
