**WIOC Online Public Inspection File**

During its most recent license term, WIOC, Ponce, Puerto Rico (Facility ID No. 8152) (“WIOC”), did not fully comply with certain online public inspection file (OPIF) requirements. By April 22, 2019, WIOC uploaded all of its Quarterly Issues/Programs Lists to its OPIF that were missing as of that date. Accordingly, as of the date of this Application, WIOC is in compliance with all of its OPIF filing requirements as further set forth below.
