Statement Regarding Public File Compliance

The FCC established a deadline of March 1, 2018 for all stations to transition to the online public file. By that date, all prior items in the paper public file were to be uploaded in the FCC's public file system. During WHPZ's transition to the online public file, the station's 2012-13 and 2014-15 EEO public file reports were uploaded on January 22, 2018 but resulted in an error that was not noted and corrected until March 22, 2018. WHPZ immediately re-uploaded the two EEO public file reports on that date. The attached screen save from the WHPZ online public file reflects the error and re-upload files and dates. Notwithstanding the above, the 2012-13 and 2014-15 WHPZ EEO public file reports were originally timely placed in the paper public file, and were available to the public.

WHPZ respectfully requests that the upload errors resulting in a brief 22-day delay in the availability of its 2012-13 and 2014-15 EEO public file reports in the station online public file be considered *de minimis* in light of the online systems

6 **What's in here?** The Commission requires stations employing five or more full-time employees to file the following forms and reports on their EEO activities and put them in their public file: (1) FCC Form 396 EEO program report that is filed with the license renewal application, Form 397 EEO mid-term report filed at the mid-point of a license term, and for buyers of a station or new licensees - a Form 396-A Model EEO Program Report; (2) The EEO public file annual report; and (3) Copies of all correspondence pertaining to an FCC investigation such as a random EEO audit (including entire audit responses with all attachments), and (4) all other material that the Commission or any of its components may require a station to keep in its public file. The Form 396, 396-A, and 397 folder is pre-populated through CDBS. All other folders are uploaded by the station individually.
