SUPPLEMENT TO INFORMAL OBJECTION

Media-Com, Inc. (“Media-Com”), by its attorneys and acting pursuant to § 73.3587 of the Commission Rules hereby submits to the Media Bureau (“Bureau”) this Supplement to its Informal Objection (this “Objection”) to the above-captioned application (the “Application”) filed by Radio.com, LLC (“Radio.com”) for FM translator W260DU, which is presently licensed as W229CG (the “Translator”) originally filed April 29, 2020 and bearing Pleading File Number 000012863.

The basic facts regarding the subject application were set forth in the Informal Objection. As stated therein, all the condition precedent requirements of Section 74.1204(f) have been met. Radio.com seeks a first adjacent channel to WNIR which would result in substantial interference to regular listeners of WNIR at locations within WNIR's 45 dBu contour. This supplement provides the additional required materials to perfect its objection and to have the Application dismissed.

Commercially Reasonable Efforts

Section 74.1204(f) requires Media-Com to use “. . . commercially reasonable efforts to inform the relevant translator licensee of the claimed interference and attempt private resolution

of the issues.” As documented and submitted with its Informal Objection, on April 17, 2020, counsel for Media-Com sent a letter to Dale Edwards, the principal of Radio.Com, advising Radio.com of the claimed interference and inviting discussions for a private resolution. That effort generated telephone discussions between the parties and their engineering consultants, but failed to produce any progress toward a useful resolution. On April 23, 2020, counsel for Media-Com send a second letter to Mr. Edwards addressing telephone discussions between the parties and detailing the attempts for a private resolution. That letter was also submitted with the Informal Objection. Media-Com received no response to the second letter or any other communication from Radio.com. Accordingly, Media-Com has met its burden under Section 74.1204(f)(4).

Required Minimum Number of Valid Listener Complaints

Using Table 1 to §74.1203(a)(3) and defined in §74.1201(k), Media-Com has calculated that it must produce ten listener complaints in the interference zone. Media-com identified twenty-three regular listeners, well more than the required number, within the area of predicted interference. Attached as Exhibit “A” hereto is an Engineering Study prepared by Carl E. Smith, Consulting Engineers (the “Engineering Study”). The Twenty-three listeners are identified by name and location on Table 1.1 of the Engineering Study. Their listener surveys are attached as Attachment “1”.

Specific Location of The Alleged Interference

The second required showing under §74.1204(f)(2) is a map plotting the specific location of the alleged interference in relation to the complaining station's 45 dB μ contour. Engineering Study Figure 1.1 identifies each of the listener by number on a map that depicts their listening location, showing them all to be within the WNIR 45 dBu contour.

WNIR Is Operating Within Its Licensed Parameters

Attached as Exhibit “B” is the declaration of William B. Klaus, Chief Operating Officer of Media-Com stating that WNIR is operating within its licensed parameters.


Undesired to desired signal strength exceeds –6 dB

The fifth and final requirement of §74.1204(f) is that each listener location the undesired to desired signal strength exceeds –6 dB for first-adjacent channel situations. The application proposes a first-adjacent channel to WNIR. For each of the listeners identified on Table 1.1, the Engineering Study provides a summary of the desired (WNIR) and undesired (W229CG) signals and the resulting undesired to desired ("U/D") signal ratio at each location. As shown by this data, the predicted WNIR signal strength at each of these locations exceeds 45 dBμ and the undesired to desired signal ratio at each location exceeds -6 dB, meeting the required standard at subsection (f)(5). And confirming that interference is predicted to WNIR at each of these locations.¹

WHEREFORE, having met all the requirements of §74.1204(f) of the Commission's rules as required to protect its station WNIR from predicted adjacent channel interference, Media-Com respectfully requests that the Bureau deny the above captioned application of Radio-Com for a change of channel for FM translator W260DU.



ENGINEERING STATEMENT

This engineering statement is prepared on behalf of Media-Com, Inc., licensee of Radio Station WNIR(FM) - Kent, Ohio. WNIR operates on Channel 261A with an effective radiated power of 4.2 kilowatts at 120 meters above average terrain. On April 9, 2020, the licensee of FM translator W229CG - Cleveland, Ohio, which presently operates on Channel 229 and is authorized to rebroadcast KHRI(FM) - Hollister, California as relayed by W215BS - Hinckley, Ohio¹, filed an application (0000111980) for a construction permit to modify the W229CG operating facilities. This application proposes to move W229CG to Channel 260 (99.9 MHz), purportedly to overcome interference presently being received on Channel 229 from cochannel stations WQGR(FM) - North Madison, Ohio and WQIO(FM) - Mount Vernon, Ohio. It also proposes to increase the translator's effective radiated power from 19 watts to 99 watts and change its primary station to a digital subchannel of WKDD(FM) - Munroe Falls, Ohio, as relayed by W224CD - Parma, Ohio. Although it appears to propose no change in the presently licensed W229CG antenna, it does specify a one meter reduction in antenna height and recharacterizes this existing antenna from nondirectional to directional.

Section 74.1204(f)(5) of the FCC Rules defines the signal ratios for determining the presence of interference in the FM translator service. In this particular case, interference will be predicted to WNIR in any area where the predicted WNIR F(50,50) signal does not exceed the predicted F(50,10) signal for the proposed W229CG facilities by at least 6 dB. Studies were conducted to evaluate the area in which interference

¹W215BS ceased operation on Channel 215 on September 19, 2017 as the result of an interference problem and moved to Channel 269 in August of 2018. Although it appears to have recently moved back to Channel 215 to attempt to overcome interference to WHOF(FM), W229CG appears to have been rebroadcasting a station other than the one authorized by their license since at least September of 2017.

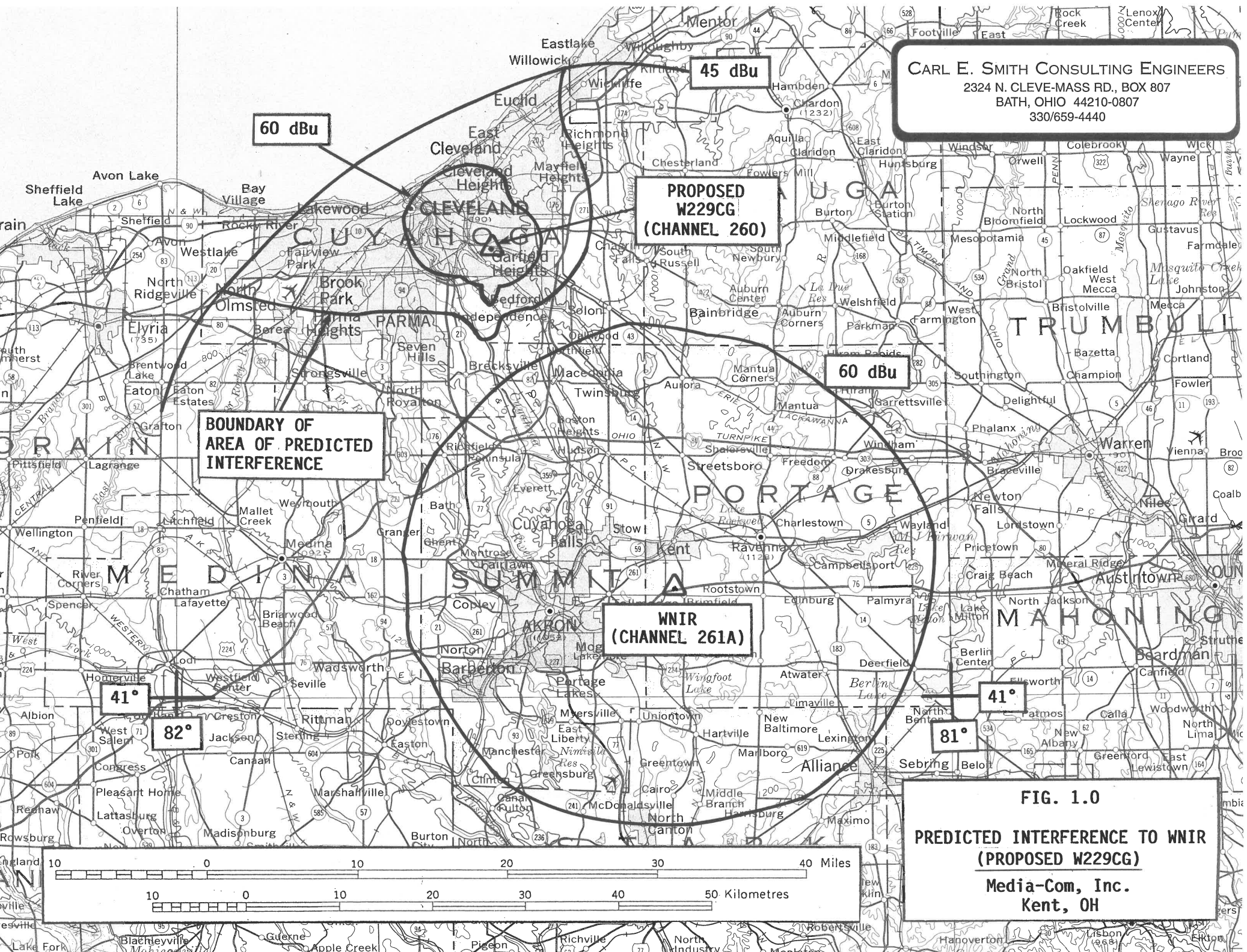
would be predicted to WNIR from these proposed translator facilities. The signal calculations in these studies for WNIR utilized terrain data extracted from the NGDC 30 second terrain database and the F(50,50) curves. Those for the proposed translator facilities utilized terrain data extracted from the NGDC 30 second terrain database and the F(50,10) curves. The results of these studies, along with the predicted 60 dBu contour for these proposed translator facilities and the predicted 45 dBu contour for WNIR's presently licensed facilities, are shown in Figure 1.0. As can be seen from an examination of this figure, these proposed translator facilities are predicted to cause interference to WNIR over an extensive area.

It is recognized that this predicted interference lies entirely outside the predicted WNIR 60 dBu contour, the contour at which WNIR would normally be entitled to protection from other FM broadcast stations. Pursuant to Section 74.1204(f) of the FCC Rules, however, since the proposed facility is a translator, the location of this interference relative to the WNIR 60 dBu contour is immaterial, so long as it is located within WNIR's 45 dBu contour and WNIR can document that it has at least ten regular listeners within this area of predicted interference.²

The licensee of WNIR has been able to specifically identify at least 23 regular listeners to WNIR within this area of predicted interference. Figure 1.1 is a detailed map exhibit depicting the locations of these regular listeners in relation to this area of predicted interference. Table 1.1 is a tabulation of the names and addresses of these 23 regular listeners, as well as a summary of the desired (WNIR) and undesired (W229CG) signals at each location and the resulting undesired to desired ("U/D") signal

²Based on 2010 census data, WNIR's 60 dBu contour encompasses 762,689 people. As a result, Section 74.1203(a)(3) of the FCC Rules requires a minimum of ten bona fide listeners within the area of predicted interference.

ratio at each location. As shown by this data, the predicted WNIR signal strength at each of these locations exceeds 45 dBu and the undesired to desired signal ratio at each location exceeds -6 dB, which confirms that interference is predicted to WNIR at each of these locations. Thus, pursuant to Section 74.1204(f) of the FCC Rules, the W229CG application must be denied since it is obvious that the proposed translator facilities will result in interference to at least 23 regular listeners of WNIR at locations within the predicted WNIR 45 dBu contour.



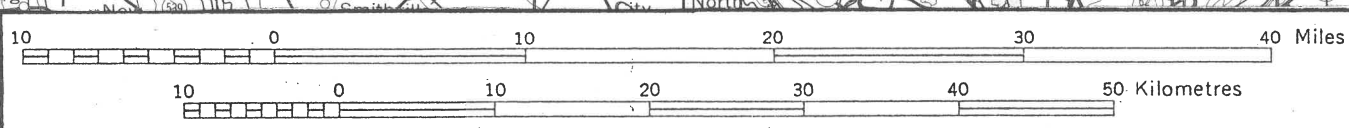

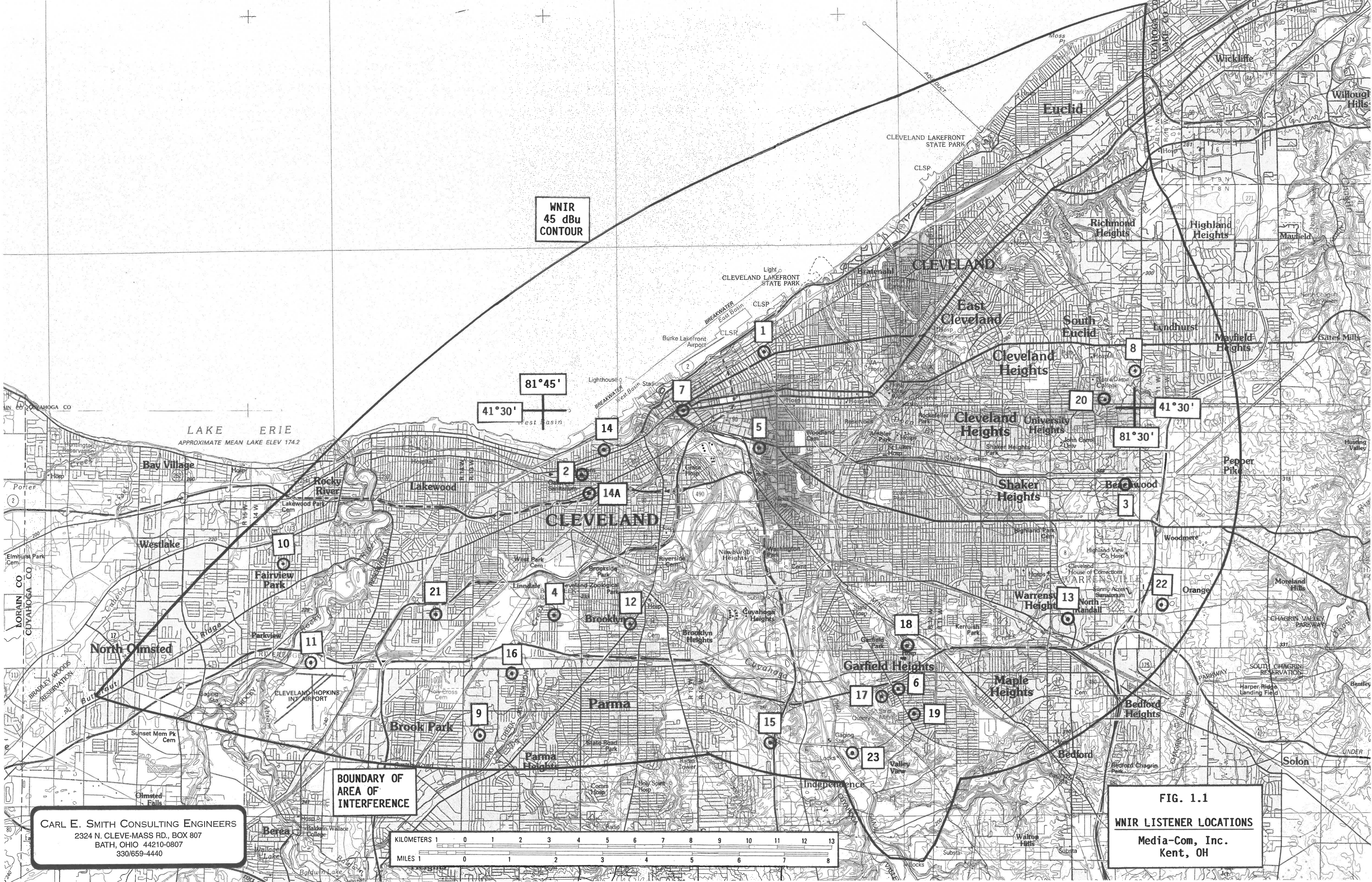
