**Subject:** WTAT-TV Quarterly Report

Barbara,

On behalf of Cunningham Broadcasting Corporation, the ultimate parent of WTAT Licensee, LLC (the "Licensee"), licensee of WTAT-TV, Charleston, South Carolina, (Fac. ID No. 416), and in response to the quarterly reporting requirement detailed in *Applications for Consent to Transfer of Control from License Subsidiaries of Allbritton Communications Co. to Sinclair Television Group, Inc.*, Memorandum Opinion and Order, 29 FCC Rcd 9156, 9169 (FCC 2014), we hereby report that the Licensee is not a party to any formal or informal sharing arrangements involving services provided to WTAT-TV by other stations in the market or by licensees, other entities, or individuals who hold an attributable interest in another station in the market other than as previously reported, (i) Sinclair Properties, LLC is leasing certain building space and equipment to WTAT-TV pursuant to a Transmission Building Lease dated July 31, 2014; and (ii) Sinclair Properties LLC d/b/a WCIV-TV is providing live feed newscasts to WTAT-TV pursuant to a News Share Agreement entered into on July 24, 2015. The News Share Agreement was amended on October 31, 2016 to provide for an additional 30-minute newscast.

While not a sharing of services, the Licensee does wish to note that due to unforeseen delays in the construction of its repack facilities, WTAT-TV previously reported it had entered into an agreement to temporarily operate using the shared facilities of WCIV-TV until its interim facilities for the repack are completed and WTAT-TV can commence operation on its post-repack channel. That continues to be the case.
