APPLICATION FOR LICENSE

The following engineering statement has been prepared for **Digital Networks-Midwest, LLC** (“Midwest”), licensee of analog low power television station K40DE, and permittee of the displaced facility K28QQ-D, also at Williston, North Dakota, and is in support of their application for license to cover the construction permit for the displaced facility.¹ This application seeks to cover the construction permit that has been assigned LMS File No. 0000120790.

Under the referenced construction permit, the facility is authorized to operate on television channel 28 with a maximum effective radiated power of 1.0 kW at a center of radiation of 661.5 meters above mean sea level, 30 meters above ground level, utilizing a Kathrein-Scala PR-TV antenna. This antenna is oriented at 225 degrees true. Midwest has completed construction of the facility utilizing the authorized parameters. The installed equipment achieves the authorized effective radiated power.

The construction permit, as issued by the Commission, lists one special condition or restriction. This condition advises Midwest that the authorization in question is for low power television. As such, it is a secondary authorization. Midwest is cognizant of the interference requirements imposed on it by the construction permit, and will comply.

Midwest certifies that it will protect workers and other personnel from being exposed to levels of radiofrequency radiation in excess of the applicable safety standards, and will coordinate
