Internship Program:

The Unit offers internships to high school students interested in a communication career. Students are able to create the kind of work they want to do in 1 semester of school. They work directly with the Program Director or News Reporter. The student and school determine and grade the project. KSJD provides the experience. We have a virtual/remote internship in the planning stages.

Education Outreach:

Every Sunday at 3:30 pm, KSJD airs a reading program in collaboration with the Cortez Public library. The children's librarian reads books to school-aged children each week.

In December of 2019, Mancos Elementary School second-graders worked with the program director and teacher/dj Kim Russell to record in the studio Letters to Santa. They each wrote and recorded a short speech and their recordings were broadcast throughout the holiday season.

Due to the Covid-19 pandemic, most of our educational outreach is on pause. In our virtual strategic planning session during the Summer of 2020, we identified that education outreach is an important and ongoing goal of the organization. We are currently working with the Ute Mountain Ute Tribe to conduct diversity training.
