INITIATIVES

The employment unit engaged in the following broad outreach initiatives in accordance with various elements of FCC Rule 73.2080(c)(2):

1. Established training programs designed to enable station personnel to acquire skills that could qualify them for higher level positions.

KDNK management worked with all full-time employees through a formal performance review to determine individual career and organizational goals, and to set forth a plan for each employee to pursue growth within the organization based on their personal wishes. This includes encouraging employees interested in learning skills in areas outside of their core responsibilities to partner with management in one-on-one training in their growth areas. Regular check-in's were held in order to track progress, and find new areas of interest within the organization. Budget decisions and staffing responsibilities were made with each employees career tract and wishes in mind. Staff attended conferences and workshops including those offered by NFCB, Rural Philanthropy Days and Rocky Mountain Community Radio.

2. Provided training to management level personnel on methods of ensuring equal employment opportunity and prevent discrimination.

Management was empowered to study and practice industry EEO standards through partnering with NPR, NFCB, Rocky Mountain Community Radio, the Colorado Broadcasters Association, the Carbondale and Basalt Chambers of Commerce, all of which have diversity and anti-discrimination hiring programs. The Board of Directors HR committee also provided training to management through regular meetings throughout the year on organizational hiring practices and diversity efforts organization-wide.
