

**Public File**

In preparing its license renewal filing, the Station conducted an audit of its online public file. It determined that in cleaning out its public file, it mistakenly removed the Issues and Program Reports from 2Q 2013 – 3Q 2014, the Commercial Limits Certifications from 2Q 2013 – 4Q 2014 and certain EEO annual reports that should have been retained in the public file. This material was originally updated timely as seen in the screenshots of the public file history below. The Station has since re-uploaded the required material.
