IT IS FURTHER ORDERED, ADJUDGED AND DECREED that defendant, CALVIN H. MURRAY, shall take such steps as are necessary to complete the aforesaid application, including, but not limited to, approving the use of his electronic signature on behalf of defendant, KP MUSIC GROUP, L.L.C., on said application. In the event defendant, CALVIN H. MURRAY, refuses to provide said approval within fifteen (15) days, or no later than November 20, 2020, WILLIAM WHITLEY, as Keeper, is hereby authorized to electronically file the application on behalf of defendant, KP MUSIC GROUP, L.L.C.


IT IS FURTHER ORDERED, ADJUDGED AND DECREED that, upon WILLIAM WHITLEY, as Keeper, obtaining control of the FCC License BLH 19960906KD as renewed BRH 20040202ASH KJMG (FM), Bastrop, LA; Facility ID No. 15095, pursuant to FCC consent, he shall be and is hereby authorized to coordinate with the Sheriff of Ouachita Parish in conducting the sale of said FCC License in accordance with La. Code of Civil Procedure Articles 2291, et seq.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the Sheriff's Sale currently scheduled for November 18, 2020, shall be and is hereby cancelled.
