Dear Ms. Dortch:

Venture Technologies Group, LLC, the licensee of low power television station WCHU-LD (Facility ID No. 129745), hereby notifies you that as permitted by the PSIP rules, WCHU-LD will broadcast programming using virtual channel 88 and 59, which it has determined will not create any conflicts.<sup>1</sup>

WCHU will broadcast programming using virtual channel 88 for its Korean language programmers. Additionally, WCHU will broadcast programming originating from WAOE (FID 52280), a commonly owned station with overlapping service areas whose major channel is 59. WCHU-LD is identifying the programming originating from WAOE using WAOE's major/minor channel number, as permitted by the PSIP rules.
