

#### AMENDED DESCRIPTION OF TRANSACTION

The licenses subject to the instant application are held by VPM Media Corporation (“VPM”). For internal business purposes, VPM and the Virginia Foundation for Public Media (“VFPFM”) intend to implement a reorganization of their structure under which: (1) VFPFM will become a Type I “supporting” organization under IRS rules, (2) VPM will become the sole member of VFPFM with authority to appoint and remove all directors of the foundation, and (3) VFPFM will no longer have the authority to appoint members to the VPM board and will not have any voting or equity rights with respect to VPM. As a result, control over VPM will transfer from the directors of VFPFM to the directors of VPM.

The chart in Attachment A depicts the complete list of current members of the board of directors of VFPFM and the complete list of current members of the board of directors of VPM.

Other than as described herein, no other changes to the ownership or management of VPM are contemplated by the reorganization.

The Commission has a policy of permitting processing of multi-station long-form applications that involve stations with pending license renewal applications where (1) no basic qualifications issues have been raised, or, if raised, were resolved favorably, and (2) the purchaser explicitly assents to standing in the stead of the seller in any renewal proceeding that is pending at the time of consummation of the transaction. VPM Media Corporation hereby agrees to succeed to the position of the transferor in any pending license renewal applications and to assume the consequences thereof, consistent with the procedures set forth in *Shareholders of CBS Corporation*, Memorandum Opinion and Order on Reconsideration, 16 FCC Rcd 16072, 16072–73 (2001) (“The Commission repeatedly has held that, in multi-station transactions, it will grant the transfer of control application while the renewal application is pending as long as there are not basic qualification issues pending against the transferor or the transferee that could not be resolved in the context of the transfer proceedings, and the transferee explicitly assents to standing in the stead of the transferor in the pending renewal proceeding.”).
