If you are claiming financial hardship, you must include a showing that includes: (a) an itemized estimate of the cost of meeting the build-out requirements; (b) a detailed statement explaining why its financial condition precludes such an expenditure; (c) a detailed accounting of the applicant's good faith efforts to meet the deadline, including its good faith efforts to obtain the requisite financing and an explanation why those efforts were unsuccessful; and (d) an indication when the applicant reasonably expects to complete construction.

Please file the above-outlined information in the form of an amendment to each of the extensions. Failure to submit this information within 30 days of the date of this letter will result in the dismissal of the extensions.
