

MULTIPLE OWNERSHIP STUDY

The following engineering statement and attached exhibits have been prepared for **Ad Astra per Aspera Broadcasting, Inc.** ("Ad Astra"), licensee of several FM broadcast stations in southern Kansas, and are an analysis of multiple ownership by Ad Astra pursuant to the provisions of Section 73.3555 of the Commission's Rules. This study is being filed as part of the application for transfer of control for the several Ad Astra facilities.

Ad Astra is the licensee of the FM stations listed in the following table.

Exhibit E-1 illustrates the predicted 70 dBu F(50,50) service contour from each of the facilities. As this map demonstrates, a contour market is created by the common overlap between these four stations. These four stations, all of which are FM stations i.e., in the same service, constitute a second-tier contour market. As a result of this grouping, it is necessary and sufficient to demonstrate that there are at least fifteen stations serving the market.

Exhibit E-2 analyzes the contour market in order to demonstrate that a sufficient number of additional stations serve the market in accordance with the interim contour methodology. The other stations considered are summarized in the following table.

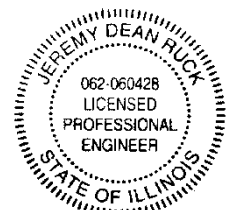

Each of these stations is located within 92 kilometers of the perimeter of the market defining contour overlap. Since a sufficient number of additional stations serve the market, it is respectfully submitted that the common ownership of the Ad Astra facilities, which has not changed, remains in compliance with the contour market provisions of Section 73.3555 of the Commission's Rules.

The Ad Astra stations are located in the vicinity of both the Wichita and the Salina-Manhattan rated radio markets. None of the stations, however, are considered home to either market based on recent BIA data. As a result, consideration under the rated market methodology is not required in this instance.
