Dear Mr. Myers:

Alan E. Karsh, licensee (the "Licensee") of the above-referenced FM translator station (the "Translator") through counsel, hereby submits documentation in response to the above-referenced inquiry (the "Inquiry"). This documentation demonstrates that the Translator was not silent in April of 2003, as suggested in the Inquiry. The documentation also demonstrates that the station was never silent at any point thereafter for a one year or longer period.

The documentation includes:

- (1) Maintenance logs and accompanying affidavit demonstrating operations during the relevant period;
- (2) Translator manager's affidavit correcting the error that initially led the Commission to believe that the station may have been silent as early as April, 2003, when it was actually on the air at that time.

**AFFIDAVIT OF WARD HOLMES**

I, Ward Holmes, being duly sworn, hereby state as follows:

I serve as a contract station manager for Alan E. Karsh, licensee of FM Translator Station K296EO, Facility Identification Number 757, Dolores, Colorado (the "Translator Station").

I mistakenly stated in an email to the FCC that the Translator Station went silent in April 2003. The Translator Station, at that time, however, was on the air providing service. It did not become silent until that summer after receipt of a letter from a full power station, with legal priority over the Translator Station, that it would soon start operations on the same channel.

The Translator Station has never been silent for a one year or longer period during any period since notice arrived from that full power station.


**AFFIDAVIT OF BRUCE ANDERSON**

The Translator Station has never been silent for a one year or longer period during my tenure as its consulting engineer, which includes that time and all times since.


